The Fund invests in units of the Barings Korea Trust (the "Trust"), which is a unit trust primarily investing in securities of equities and equity-related securities of companies incorporated in, or exercising the predominant part of their economic activity in Korea, or quoted or traded on the stock exchanges in Korea.
2. The Fund is subject to risks, such as investment, equities and equity-related securities, currency and risks of investing in small and mid-capitalisation companies, convertible bonds as well as risks relating to master/feeder fund structure.
3. The Fund's investment (through its investment in Barings Korea Trust) is concentrated in Korean companies and the value of Fund may be more volatile. 


