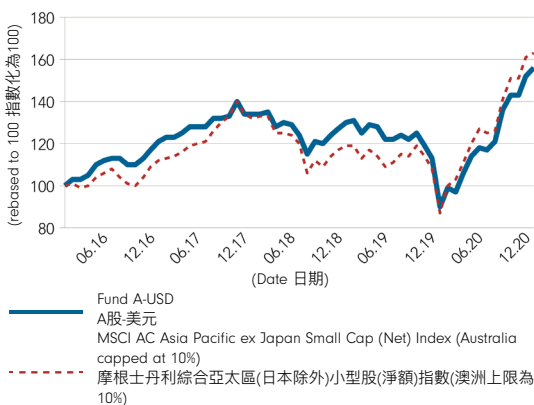

The fund is an Equity fund and aims to achieve long-term capital growth by investing primarily (i.e. at least 70% of the fund's assets) in a diversified portfolio of smaller companies that have their head office or exercise a predominant part of their activities in Asia Pacific (excluding Japan). 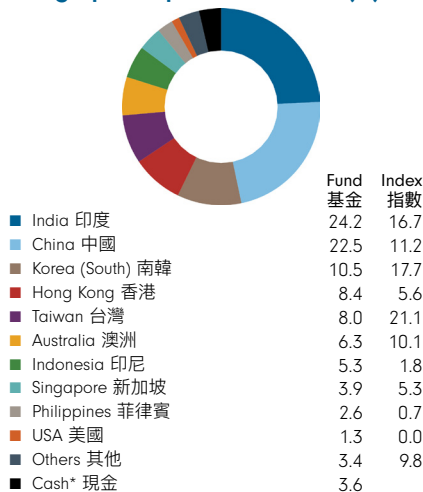

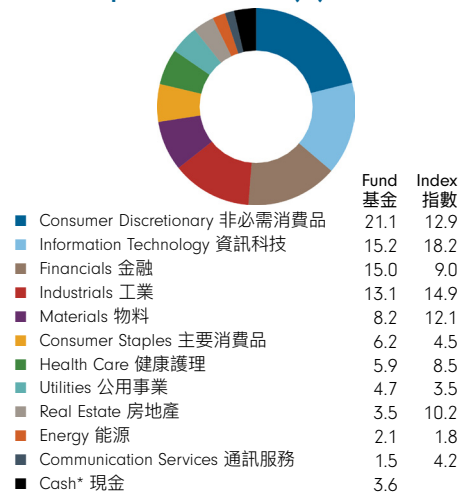
