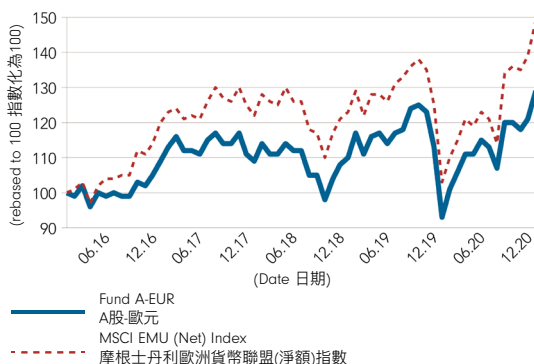
- This fund invests primarily in blue chip equities in those countries which are members of the Economic Monetary Union (EMU) and primarily denominated in Euro.

### Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to provide long-term capital growth with the level of income expected to be low. The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in blue chip equities in countries that are members of the Economic and Monetary Union and at least 70% of which are denominated in Euro. 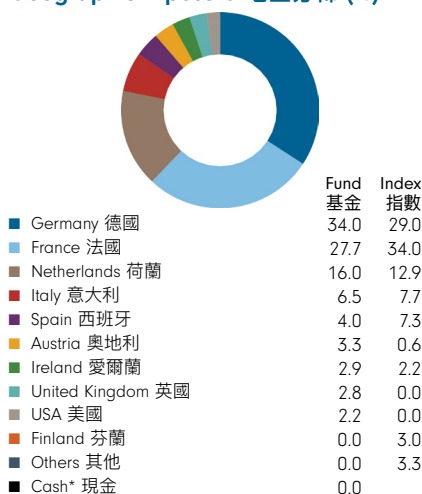

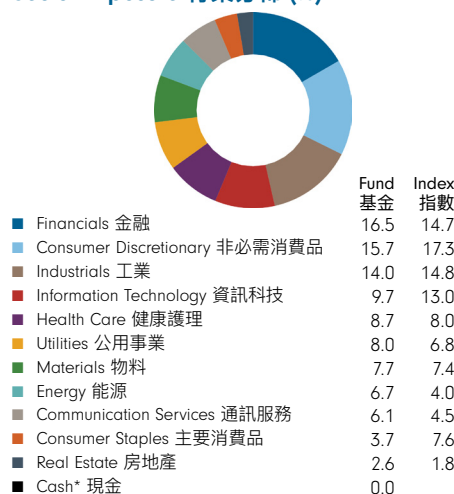
