Important Information

The fund invests primarily in equity and equity related securities of emerging markets companies.

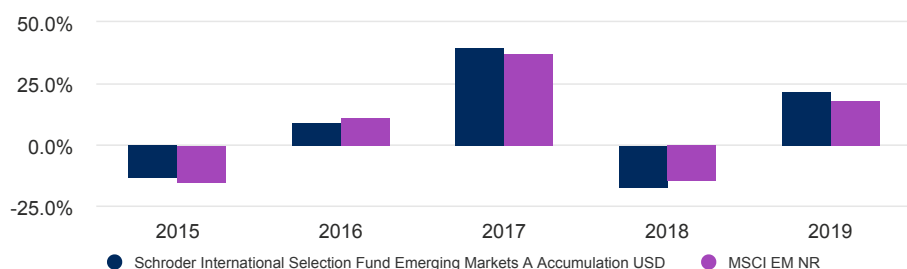

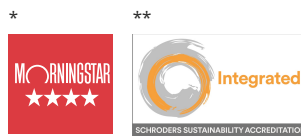

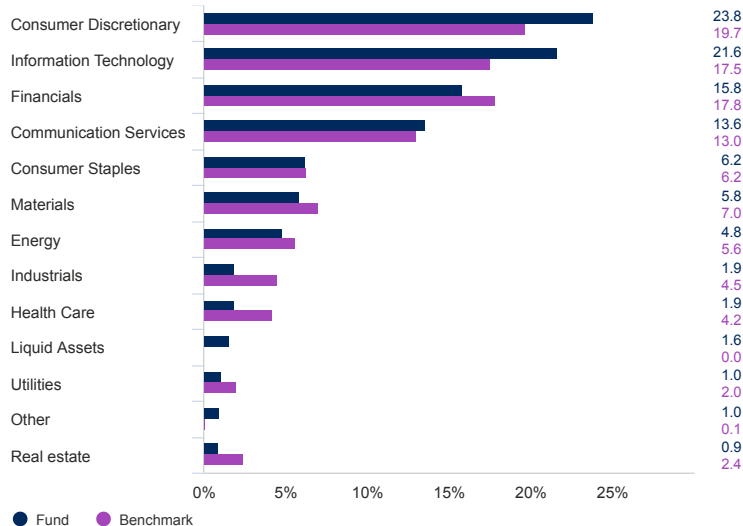

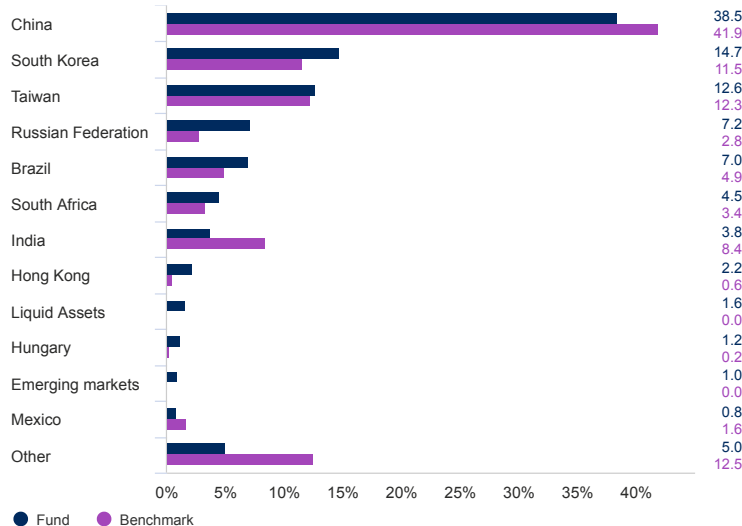

Geographical Breakdown (%)

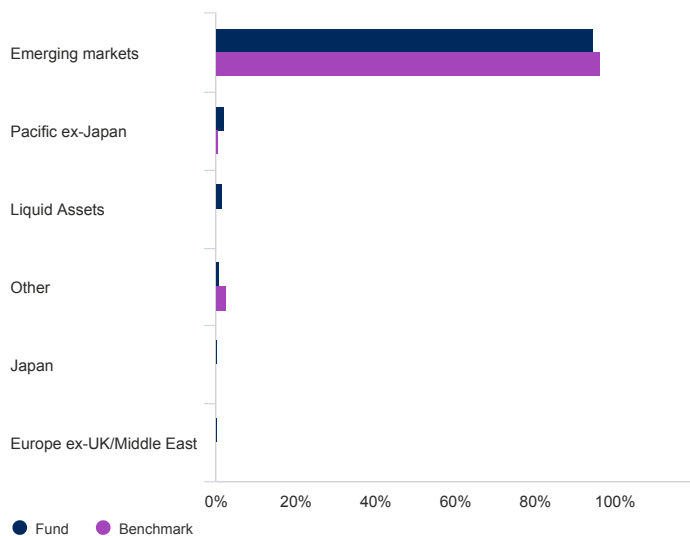
