### Investment Objective & Strategy

The Fund seeks long-term capital growth and income, allocating assets between equity and debt securities based on an assessment of current business, economic and market conditions. Normally, equity and debt securities each represent 35% to 65% of assets. To implement that objective, the entire Fund initially will be invested in the Pioneer Balanced Sustainable Trust, a collective investment fund that Wilmington Trust, N.A. is trustee and Amundi Asset Management US, Inc is the sub-advisor.

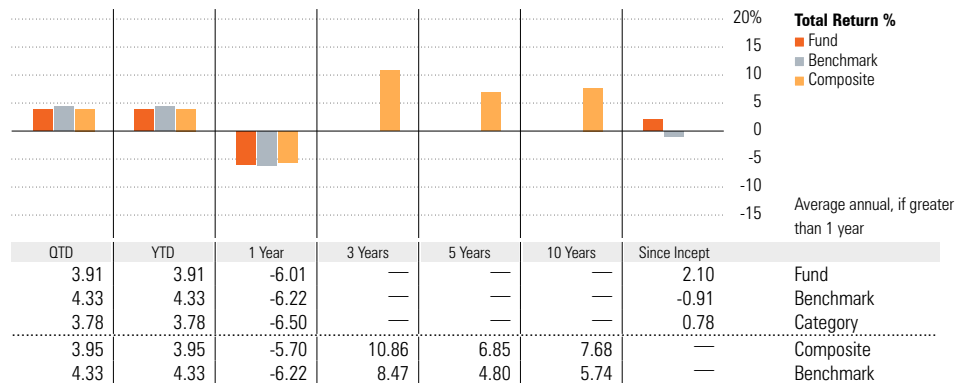

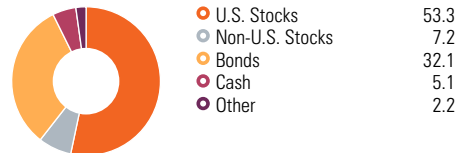

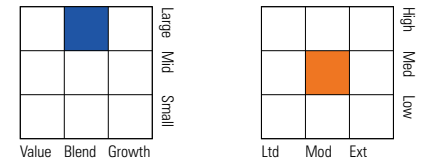

## Divestiture Notice

On December 19, 2022, Wilmington Trust, N.A. entered into a definitive agreement to sell its collective investment trust business ("CIT Business") to an affiliate of Madison Dearborn Partners, LLC (the "Transaction"). In connection with the Transaction, Wilmington Trust, N.A. will be assigning and transferring the assets and liabilities of the CIT Business to a newly formed Nevada chartered non-depository trust company. It is anticipated that the Transaction will be completed in the first half of 2023. ## Investment Information

**Fund Structure.** Balanced Sustainable Fund Class I1 ("Fund") is a bank collective investment trust ("CIT") maintained by Wilmington Trust, N.A. ("Trustee") as part of the Wilmington Trust Collective Investment Trust, which was established on October 6, 2005 and most recently amended on June 20, 2016 ("Trust"). The Fund is a "group trust" within the meaning of Internal Revenue Service Revenue Ruling 81-100, as amended. The Fund and its securities are exempt from registration under the Securities Act of 1933 and the Investment Company Act of 1940. It is not a mutual fund. See "Comparisons between CITs and Mutual Funds" below. Participation in CITs is limited to qualified defined contribution plans and certain state and local government plans and is not available to IRAs, health and welfare plans and in certain cases Keogh (H.R.10) plans. CITs may be suitable investments for participants seeking to construct a well-diversified retirement savings program.

## Investment Process

**Investment Objective.** The Trustee may change the Fund's investment objective, subject to appropriate advance notice. There is no guarantee that the Fund will achieve its investment objective.

Environmental, Social & Governance Exposure (ESG) Funds are portfolios of equities and/or bonds that integrate social and governance factors into the investment process. The portfolios contained in the underlying fund have passed stringent tests over how sustainable the company or government is regarding its ESG criteria. The sub-advisor of the underlying fund believes that the use of ESG in security selection leads to better-informed investment decisions, and that sustainability funds can perform better than non-sustainable ones due to better risk management over contentious issues.

Equity:

Idea generation

Stock ideas come from both the portfolio management and analyst teams. Formal interaction between the portfolio managers and analysts occurs in daily meetings, weekly meetings and portfolio reviews. There are also frequent stock pitch meetings in which analyst's present stock recommendations supported by written research reports and detailed financial models and analysis, including ESG ratings and considerations.

Research and Valuation

The portfolio manager in conjunction with the relevant analyst performs fundamental analysis on stock ideas, assessing the fit relative to the strategy specific criteria, which are as follows:

- Sustainable Business - ESG considerations, competitive advantage/unique set of assets/financial stability
  - Attractive Valuation – market relative P/E, free cash flow yield, EV/EBITDA, EVA
  - Identifiable Catalyst – new product or service, new management, cost synergies
- Fixed Income:

Broad Sector Allocation

The asset allocation strategy among U.S. dollar fixed income sectors integrates bottom-up themes from the analyst team with top-down views of economic indicators and market trends. In particular, they analyze interest rates, economic and credit cycles, currency and political factors, fundamentals, and relative value. Relative value focuses on spreads vs. long term averages and spread relationships among asset classes vs. long term averages, viewed in the context of the current economic, credit and interest rate environment. All exposures are considered with respect to contribution to overall portfolio return and the contribution of separate risk factors to overall risk.

The strategy tends to separate exposure decisions into investment grade, non-investment grade, and non-U.S. The underlying fund sub-advisor compares agency MBS primarily as an alternative to Treasuries and investment grade corporates. To that end, they manage the overall exposure of the portfolio to the negative convexity of mortgages. The strategy invests in high yield corporates and bank loans, non-agency MBS and ABS, and (to a very small extent) emerging markets, as opportunistic value investments.

Credit Quality

The overall credit quality decision is dictated by the investment guidelines and risk tolerances set forth in the prospectus. Within those limits, the team assesses a number of factors including the economic and broad market outlook, the position in the credit cycle, default risk, recovery rates, spreads, and market dynamics (including issuance trends, investor flows). Internal parameters set a maximum allocation of 20% to below investment-grade securities.

Duration and Yield Curve Strategy

Duration and yield curve represent only secondary alpha drivers for the strategy. Duration and yield curve positions are based on the Underlying Fund sub-advisor's views of broad trends and large changes over longer horizons, rather than short-term rate moves.

## Operations and Management

**Trustee:** Wilmington Trust, N.A. ("Trustee") serves as the Fund's trustee and maintains ultimate fiduciary authority over the management of, and investments made in, the Fund. The Trustee is a subsidiary of M&T Bank Corporation.

Wilmington Trust is a registered service mark used in connection with various fiduciary and non-fiduciary services

offered by the Trustee and certain other subsidiaries of M&T Bank Corporation.

**Sub-Advisor:** flexPATH Strategies, LLC ("Sub-Advisor") is a registered investment adviser that has been hired by the Trustee to assist it in managing the Fund. However, the Trustee maintains ultimate authority over the Fund.

flexPATH Strategies, LLC was established and began managing assets in June 2015. flexPATH Strategies designs, manages and oversees custom asset allocation strategies designed exclusively for retirement plans. flexPATH Strategies is located in Aliso Viejo, CA.

**Key Comparisons between CITs and Mutual Funds.** CITs are tax-qualified investments primarily restricted to the retirement market so investors tend to have a longer-term horizon and the trustee can make investment decisions without tax considerations. Mutual funds are not subject to these investor limits or investment horizons, and must distribute substantially all of their taxable net gains and income to investors. CIT expense structures can be customized to investor channels. Mutual funds generally have less fee flexibility. CITs tend to have lower administrative, marketing and distribution costs than mutual funds due to the differences in how they can be sold and to whom. CITs are maintained by a bank as trustee and are

subject to federal or state banking regulation and ERISA fiduciary standards. Mutual funds are managed by registered investment advisers and are subject to extensive SEC regulation and public disclosure and reporting requirements. Both CITs and mutual funds are generally priced and traded daily, subject to annual financial audits, and benefit from their pooled structure that aggregates investor funds and can provide greater diversification than individual accounts.

## Performance

## Chart Explanations

The following are explanations of some terms used in the Volatility Analysis, Portfolio Analysis, and Performance charts.

## Volatility Analysis

*Standard deviation* indicates the percentage by which a portfolio's performance has varied from its average performance in any given month during the period indicated. The higher the standard deviation, the greater the range of performance, indicating greater volatility.

*Sharpe ratio* refers to a risk-adjusted measure calculated using standard deviation and excess returns to determine reward per unit of risk. The higher the ratio, the better the fund's historical risk-adjusted performance.

*Information Ratio* is a risk-adjusted performance measure. The information ratio is a special version of the Sharpe Ratio in that the benchmark doesn't have to be the risk-free rate.

*R-squared* measures how closely a fund's performance correlates with that of its benchmark, thus representing how much of the fund's performance can be explained by the overall market or index. 1 indicates perfect correlation; 0 indicates no correlation.

*Beta* is a measure of a portfolio's volatility, or systematic risk, in comparison to a benchmark. Systematic risk is the tendency of the values of the fund and the benchmark to move together. A beta below 1 indicates less volatility than the benchmark; a higher beta indicates more volatility. A negative beta indicates the fund tends to move opposite its

benchmark.

*Alpha* is a measure of performance on a risk-adjusted basis. The excess return of the fund relative to the return of the benchmark index is a fund's alpha. A positive Alpha figure indicates the Fund has performed better than its Beta would predict. In contrast, a negative Alpha indicates the Fund has underperformed, given the expectations established by Beta.

## Portfolio Analysis

*Credit Analysis* represents the grading of a debt security with respect to the issuer's ability to meet interest and principal requirements in a timely manner. Ratings by S&P, Moody's, or any other Nationally Recognized Security Rating Organization (NRSRO) are measured on a scale that generally ranges from AAA (highest) to D (lowest). Issues rated AAA, AA, A and BBB are considered investment grade. Bonds, including government and government-related, not rated by a NRSRO are included in the Not Rated category. Higher-rated bonds generally provide lower returns and greater safety. Weighted average ratings methodology uses the highest of any NRSRO. Portfolio average credit quality is calculated on a dollar-weighted basis.

*Sector diversification* is broken out among common fixed income sectors including U.S. Treasury and Treasury futures, U.S. Government Agency, mortgage-backed securities (MBS), collateralized mortgage obligation (CMO), asset-backed securities (ABS), commercial mortgage-backed securities (CMBS), corporate bonds (Corp), which includes structured securities such as collateralized loan obligations, convertibles (Conv) and, Cash (Cash/Other).

**Benchmark:** Morningstar Mod Tgt Risk TR USD The Morningstar Target Risk Index family is designed to meet the needs of investors who would like to maintain a target level of equity exposure through a portfolio diversified across equities, bonds and inflation-hedged instruments. The Morningstar Moderate Target Risk Index seeks approximately 60% exposure to global equity markets. This Index does not incorporate Environmental, Social, or Governance (ESG) criteria.

The Fund performance is accompanied by performance of a published index selected based on the Fund strategy in an effort to compare the performance of a market of securities commonly seen as eligible for that strategy. Indices are unmanaged and not available for direct investment. Indices do not reflect expenses that are borne by investors in the Fund, such as management fees and transaction costs, which reduce returns.

**Composite** The US Balanced Composite ("Composite") invests for a balance of capital growth from common stocks and securities with common stock characteristics and current income from fixed-income securities. Typically, the mix between equity and debt will range from 35% to 65%. The Composite's minimum account size is \$1 million. The Composite includes 3 portfolios and \$515 million in aggregate assets at 6/30/2022.

The Composite includes all client portfolios managed and identified by the Sub-Advisor (or if the Fund invests in an Underlying Fund, by the Underlying Fund Advisor) that have investment objectives, policies, and strategies that are

substantially similar to those of the Fund.

The Composite performance information is included because the Fund has a limited performance history and the Composite provides comparative past performance of such substantially similar strategy for a longer time period relative to the Fund's benchmark. The Composite performance reflects the reinvestment of income and the deduction of trading expenses, and has been adjusted to reflect the maximum fees and expenses that a Fund investor would bear, including management fees, custody fees and operating expenses of the Fund (and, if applicable, fees and expenses of the Underlying Fund). Composite valuations and returns are computed in U.S. Dollars ("USD") and reflect currency exchange rate impacts when investments are made in other currencies.

Despite the similar strategy management of the Composite and the Fund, investment results between the Fund and the Composite as well as among portfolios in the Composite can vary due to a number of factors. Some of the key factors that can impact investment results would be differences in the specific investment management guidelines and any unique restrictions such as ERISA investment restrictions applicable to the Fund, the timing and direction of cash flows relative to changes in market valuation, differing liquidity needs that impact cash holdings, differences in asset sizes and the impact on pricing and execution of investments, the differences in the types of investors and their trading activities (for example, retirement plans tend to have longer investment horizons and Plans and their participants tend to invest on a more periodic basis), different inception dates, and different regulatory, securities and tax regimes, restrictions or limitations to which the portfolios and Fund are subject.

## Third Party Rating

Morningstar is a third party that provides certain Fund ratings by applying its proprietary methodology based on different time periods as described above through the date of this Fact Sheet. The Trustee compensates Morningstar for production of the Fact Sheets but not for the ratings. The Sub-Advisor or Underlying Fund Manager may have independent agreements with Morningstar that do not relate to the Fund rating. Any published third-party rankings, awards or similar groupings have inherent limitations and qualifications, and are not indicative of the experience of any client or investor or of the future performance of the Fund. There can be no assurance that the universe upon which the awards were based included all investment products within each category that are actually in operation or existence. The investment products on which the ratings were based may differ substantially in terms, objective, strategy, target risk return profile and certain other significant respects from those referenced herein with respect to the Fund.

## Morningstar Category: Moderate Allocation

Funds in allocation categories seek to provide both income and capital appreciation by primarily investing in multiple asset classes, including stocks, bonds, and cash. These moderate strategies seek to balance preservation of capital with appreciation. They typically expect volatility similar to a strategic equity exposure between 50% and 70%.

## Morningstar Rating™

# Disclosure

The Morningstar Rating™ is provided for those collective investment trusts (CITs) with at least a three-year history. Ratings are based on the CIT's Morningstar Risk-Adjusted Return measure which accounts for variation in monthly performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. Morningstar compares each CIT's risk-adjusted return against the breakpoints for the exchange-traded fund and open-end mutual fund universe for that category. The top 10% of exchange-traded and open-end mutual funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. The CIT's Morningstar Rating does not affect the retail fund data published by Morningstar.

## Morningstar Return

The Morningstar Return rates a fund's performance relative to other managed products in its Morningstar Category. It is an assessment of a product's excess return over a risk-free rate (the return of the 90-day Treasury Bill) in comparison with the products in its Morningstar category. In each Morningstar category, the top 10% of products earn a High Morningstar Return (High), the next 22.5% Above Average (+ Avg), the middle 35% Average (Avg), the next 22.5% Below Average (- Avg), and the bottom 10% Low (Low). Morningstar Return is measured for up to three time periods (three, five, and 10 years). These separate measures are then weighted and averaged to produce an overall measure for the product. Products with less than three years of performance history are not rated.

## Morningstar Risk

Morningstar Risk evaluates a fund's downside volatility relative to that of other products in its Morningstar Category. It is an assessment of the variations in monthly returns, with an emphasis on downside variations, in comparison with the products in its Morningstar category. In each Morningstar category, the 10% of products with the lowest measured risk are described as Low Risk (Low), the next 22.5% Below Average (-Avg), the middle 35% Average (Avg), the next 22.5% Above Average (+ Avg), and the top 10% High (High). Morningstar Risk is measured for up to three time periods (three, five, and 10 years). These separate measures are then weighted and averaged to produce an overall measure for the product. Products with less than three years of performance history are not rated.

## Morningstar Style Box™

The Morningstar Style Box™ reveals a fund's investment strategy as of the date noted on this report. For equity funds, the vertical axis shows the market capitalization of the long stocks owned, and the horizontal axis shows the investment style (value, blend, or growth.) A darkened cell in the style box matrix indicates the weighted average style of the portfolio. For portfolios holding fixed-income investments, a Fixed Income Style Box is calculated. The vertical axis shows the credit quality based on credit ratings and the horizontal axis shows interest-rate sensitivity as measured by effective duration. There are three credit categories - "High", "Medium", and "Low"; and there are three interest rate sensitivity categories - "Limited", "Moderate", and "Extensive";

resulting in nine possible combinations. As in the Equity Style Box, the combination of credit and interest rate sensitivity for a portfolio is represented by a darkened square in the matrix. Morningstar uses credit rating information from credit rating agencies (CRAs) that have been designated Nationally Recognized Statistical Rating Organizations (NRSROs) by the Securities and Exchange Commission (SEC) in the United States. For a list of all NRSROs, please visit <https://www.sec.gov/ocr/ocr-current-nrsros.html>. Additionally, Morningstar will use credit ratings from CRAs which have been recognized by foreign regulatory institutions that are deemed the equivalent of the NRSRO designation. To determine the rating applicable to a holding and the subsequent holding weighted value of a portfolio two methods may be employed. First is a common methodology approach where if a case exists such that two CRAs have rated a holding, the lower rating of the two should be applied; if three or more CRAs have rated a holding, the median rating should be applied; and in cases where there are more than two ratings and a median rating cannot be determined, the lower of the two middle ratings should be applied. Alternatively, if there is more than one rating available an average can be calculated from all and applied. Please Note: Morningstar, Inc. is not an NRSRO nor does it issue a credit rating on the fund. Credit ratings for any security held in a portfolio can change over time. Morningstar uses the credit rating information to calculate a weighted-average credit quality value for the portfolio. This value is based only upon those holdings which are considered to be classified as "fixed income", such a government, corporate, or securitized issues. Other types of holdings such as equities and many, though not all, types of derivatives are excluded. The weighted-average credit quality value is represented by a rating symbol which corresponds to the long-term rating symbol schemas employed by most CRAs. Note that this value is not explicitly published but instead serves as an input in the Style Box calculation. This symbol is then used to map to a Style Box credit quality category of "low," "medium," or "high". Funds with a "low" credit quality category are those whose weighted-average credit quality is determined to be equivalent to the commonly used High Yield classification, meaning a rating below "BBB", portfolios assigned to the "high" credit category have either a "AAA" or "AA+" average credit quality value, while "medium" are those with an average rating of "AA-" inclusive to "BBB-". It is expected and intended that the majority of portfolios will be assigned a credit category of "medium". For assignment to an interest-rate sensitivity category, Morningstar uses the average effective duration of the portfolio. From this value there are three distinct methodologies employed to determine assignment to category. Portfolio which are assigned to Morningstar municipal-bond categories employ static breakpoints between categories. These breakpoints are: "Limited" equal to 4.5 years or less, "Moderate" equal to 4.5 years to less than 7 years; and "Extensive" equal to more than 7 years. For portfolios assigned to Morningstar categories other than U.S. Taxable, including all domiciled outside the United States, static duration breakpoints are also used: "Limited" equals less than or equal to 3.5 years, "Moderate" equals greater than 3.5 years but less than or equal to 6 years, and "Extensive" is assigned to portfolios with effective durations of more than 6 years.

Note: Interest-rate sensitivity for non-U.S. domiciled portfolios (excluding those in Morningstar convertible categories) may be assigned using average modified duration when average effective duration is not available. For portfolios Morningstar classifies as U.S. Taxable Fixed-Income, interest-rate sensitivity category assignment is based on the effective duration of the Morningstar Core Bond Index (MCBI). The classification assignment is dynamically determined relative to the benchmark index value. A "Limited" category will be assigned to portfolios whose average effective duration is between 25% to 75% of MCBI average effective duration, where the average effective duration is between 75% to 125% of the MCBI the portfolio will be classified as "Moderate", and those portfolios with an average effective duration value 125% or greater of the average effective duration of the MCBI will be classified as "Extensive".

## Fees and Expenses

An investor in the Fund will bear its pro rata portion of Fund and share class fees and expenses, including applicable Trustee fees, Sub-Advisor fees, contract fees, and other operating expenses related to the Fund. Other operating expenses may include, but are not limited to, audit expenses, custody service fees, transfer agency fees, tax form preparation expenses, legal and other fees, and expenses incurred in connection with the investment and reinvestment of Fund assets (including, without limitation, any transfer agency fees, brokerage commissions and expenses). The Fund will reimburse the Trustee for all fees and expenses it incurs on the Fund's behalf.

If the Fund invests in one or more underlying funds, then Fund investors also would indirectly incur the expenses of the underlying fund(s), including any fees paid to the underlying fund manager. The expenses of the underlying fund(s) are expensed directly to the underlying fund(s) unless otherwise noted in this section or the Participation Agreement, which must be carefully reviewed and signed by the plan sponsor or plan fiduciary prior to investing in the Fund. Expenses of the underlying fund(s) may change, impacting the performance of the underlying fund(s) and therefore the ultimate Fund performance as an investor in the underlying fund(s).

For additional details on fees and expenses, investors can refer to the Participation Agreement.
