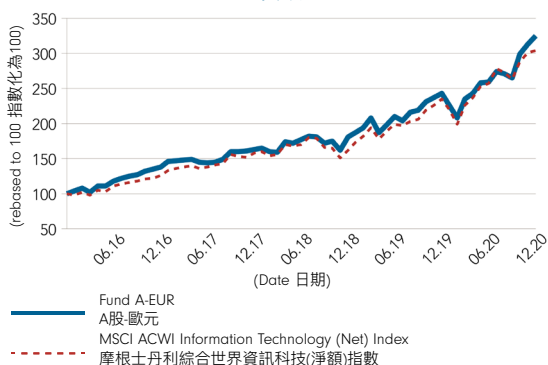

The fund is an Equity fund and aims to provide investors with long-term capital growth, principally (i.e. at least 70% (and normally 75%) of the fund's assets) through investment in equity securities of companies throughout the world that have, or will, develop products, processes, or services that will provide, or will benefit significantly from, technological advances and improvements. 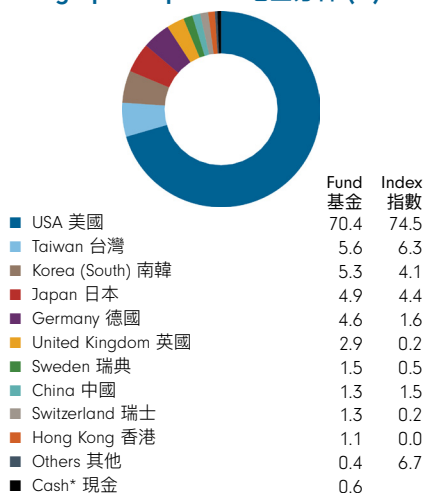

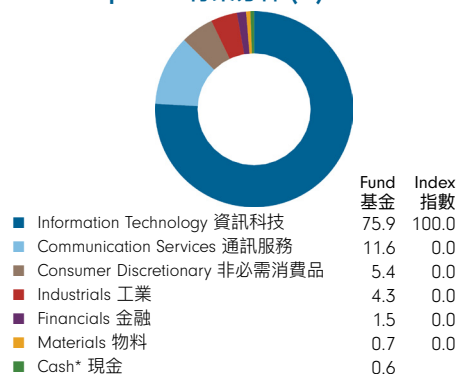
