

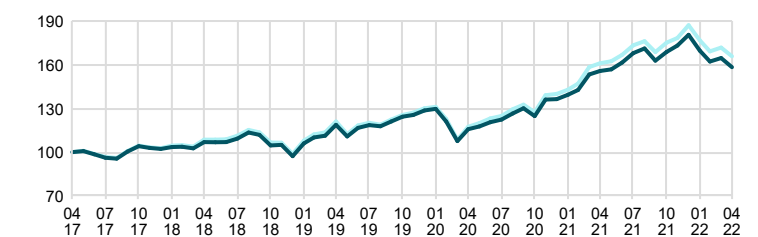
GodFond Sverige & Världen is an equity fund that aims to track developments in the Swedish and the global equity market, in both developed countries and emerging markets. The fund is managed as an indextracking fund and does not adopt any active positions versus the market. The fund optimizes the selection of companies that ranked high in sustainability based on our criteria for sustainability rating. The sustainability rating means that we do not invest in companies that contribute to the violation of human rights, corruption, harming the climate and environment, the production of landmines, cluster munitions, or nuclear weapons. In addition, the Fund also refrains from investing in companies whose turnover is more than 5 percent from production/distribution from: fossil fuels, weapons/arms, tobacco, alcohol, gambling, pornography, cannabis and companies with large fossil reserves.

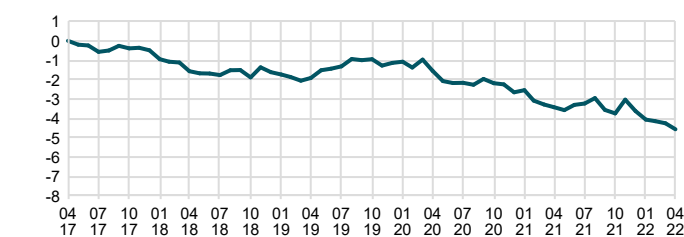

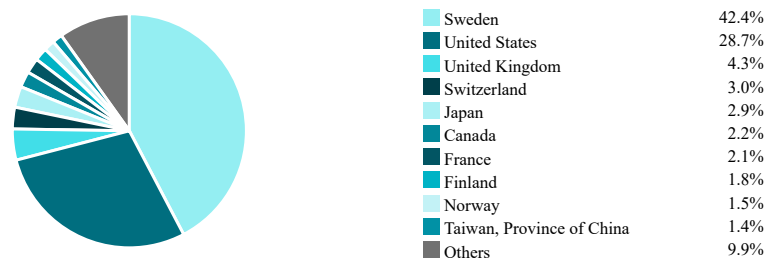
Excess Performance

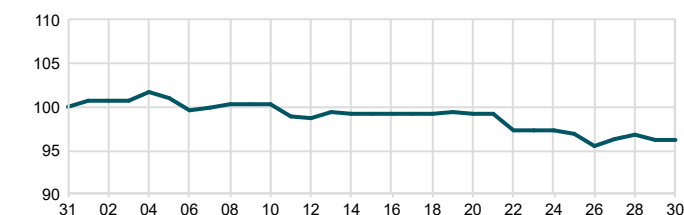

Fund Country Breakdown



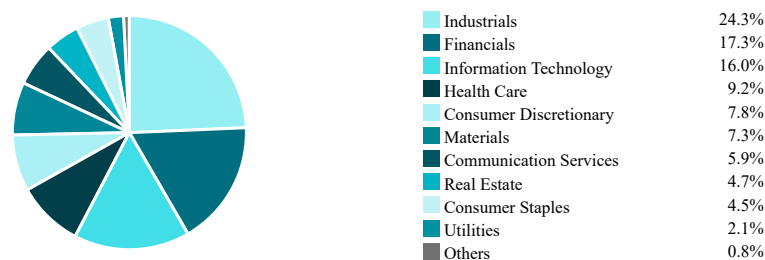

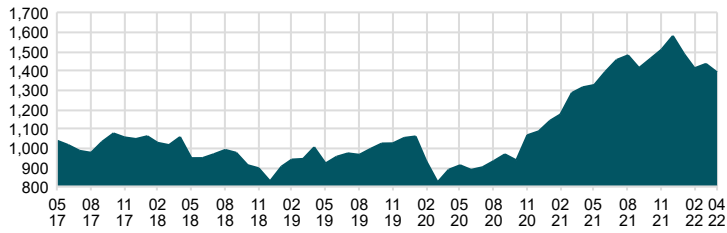

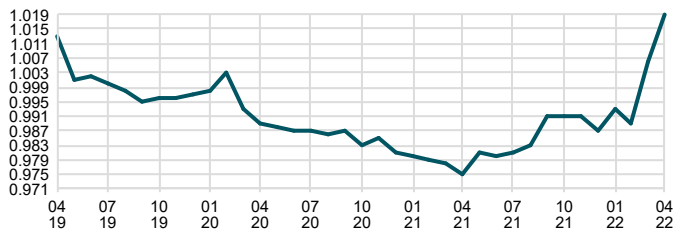

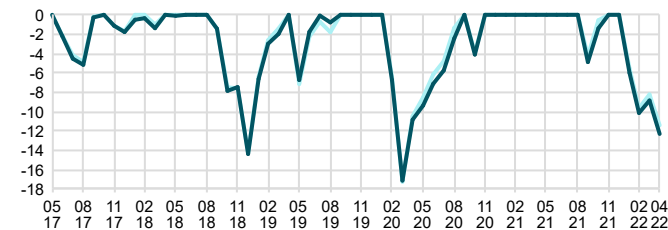
Rolling Window: 2 Years 1 Month shift

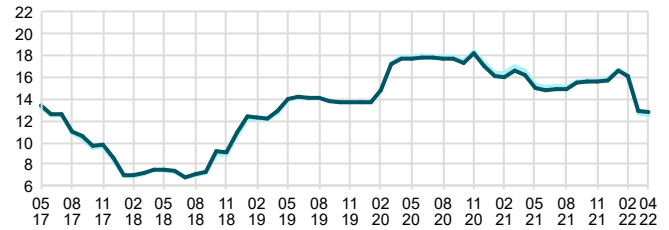

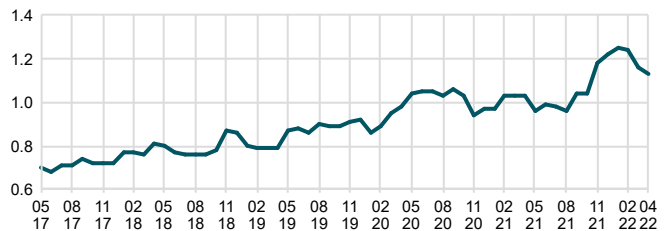

Time Period: 2017-05-31 to 2022-04-30

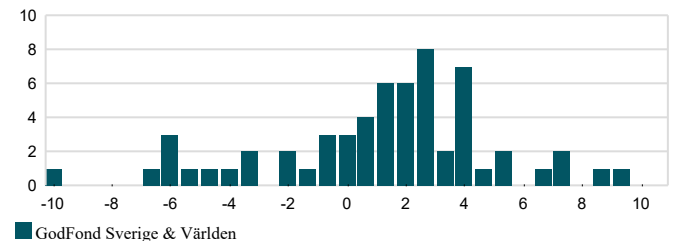
Rolling Window: 2 Years 1 Month shift
