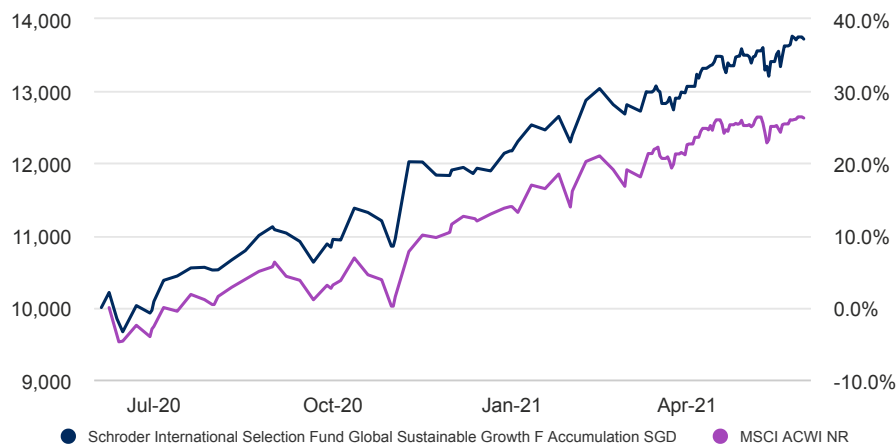

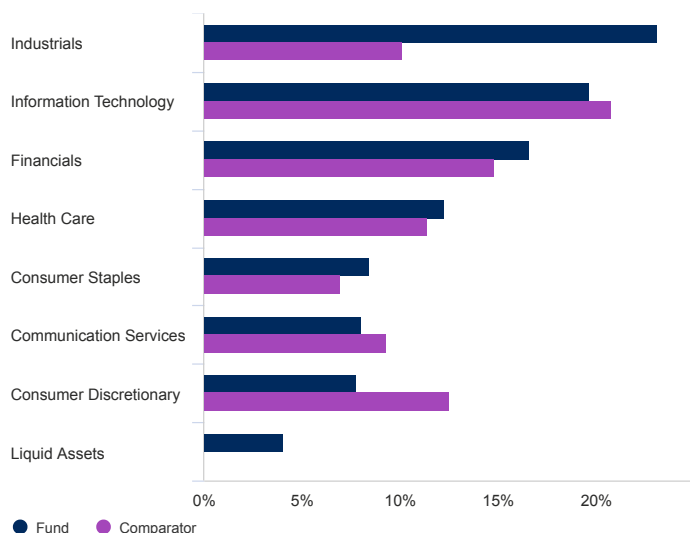

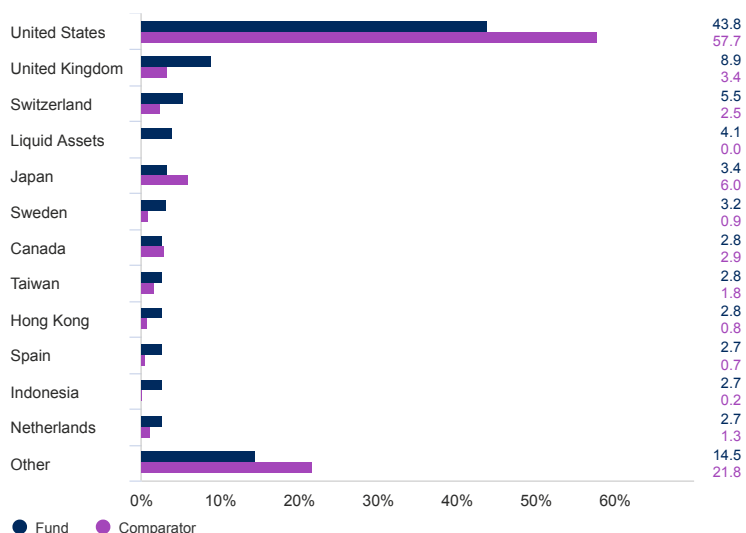

### Asset allocation

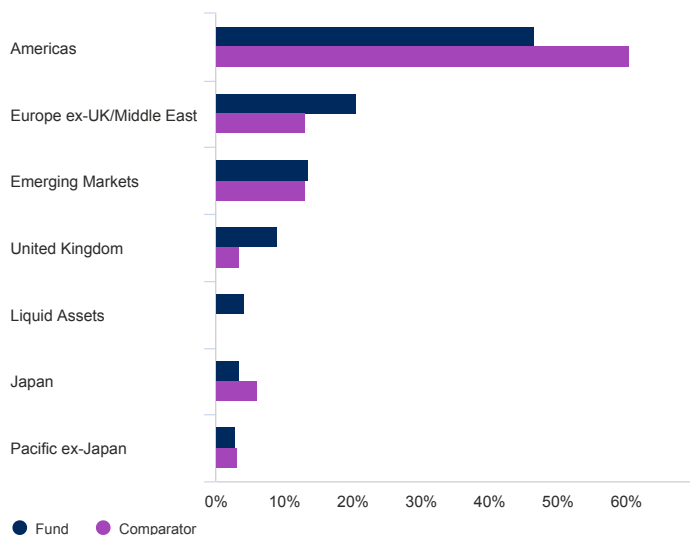
#### Sector (%)
