- This fund invests primarily in global investment grade corporate bonds and government bonds of varying maturities, and high yield bonds and emerging market debt, and seek to maintain an average duration of investments that does not

The fund is a Bond Fund and seeks to deliver an attractive income whilst maintaining an average duration of investments that does not exceed three years. The fund primarily (i.e. at least 70% of the fund's assets) invests in a portfolio of global fixed income securities, including, but not limited to, investment grade* corporate bonds and government bonds of varying maturities, and high yield bonds and emerging market debt denominated in various currencies. 


