What is this product?

Type: Feeder fund (AIF)

Term: Recommended minimum holding period: 5 years

Objective: The fund is a special feeder fund and invests the majority of its capital in AMF Aktiefond Global (minimum 85 per cent) and uses loans for the purpose of generating leverage. The special feeder fund will primarily invest in AMF Aktiefond Global but may also choose to invest in other funds managed by AMF Fonder. The fund may make investments in derivatives and in cash. Equity and/or fixed income investments made by the master fund and other underlying funds have investment policies covering a wide range of financial markets.

The special feeder fund's objective is to provide a long-term return exceeding its benchmark by using leverage and maintaining risk diversification.

The fund is actively managed. Deviations from its benchmark may vary over time, please refer to the fund's annual report and prospectus for actual historical variations. Equity, asset class and regional exposure (as applicable) may vary depending on the fund manager's assessment and always in relation to the fund's risk limits.

The fund is subject to certain sustainability criteria. Please refer to AMF Fonder's annual report on our website or the fund's prospectus for a comprehensive report on sustainable investments.

We compare the fund's performance with the benchmark MSCI ACWI NR (from 1 November 2022; previously MSCI ACWI ESG Leaders NR). The fund does not distribute dividends.

Intended Retail Investor: This fund may be appropriate for investors who plan to retain their investment for at least five years and who understands that the value of the fund can increase as well as decrease and it is not for certain that the invested amount can be recovered. There are no prior knowledge of financial markets nor experience of mutual funds necessary to be able to invest in the fund.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 year(s). This product has no maturity date.

We have classified this product as 5 out of 7. This is a medium-high risk class, which entails a medium-high risk of both increases and decreases in unit value.

The risk indicator illustrates how much the fund's value has fluctuated over the past ten years.

Category 1 (lower risk) does not mean that a fund is risk-free. A fund may move along the scale over time, to both the right and

the left. This is because the indicator is based on historical data, which are no guarantee of future risks/rewards. Even if the fund is in the lowest risk class you can lose money, as no investments are entirely risk free.

Risks not covered by the risk indicator

Performance Scenarios

The amounts shown here are the cumulative costs of the product itself, for different holding periods given the moderate scenario. The figures assume you invest SEK 100,000. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance.
