INVESTMENT OVERVIEW


Objective

To preserve the value of your investment, while achieving a return in line with money market rates. **Reference Index**

US Generic Govt 1M, an index that does not take into account environmental, social and governance (ESG) factors. Used for performance measurement. **Portfolio Assets**

The Compartment mainly invests in deposits and in short-term, highly rated investment-grade money market instruments that are either denominated in US dollar (USD) or systematically hedged to this currency (meaning investments have little or no exposure to currency risk). These are issued by governments or public organisations in developed countries. **Investment Process**

In actively managing the Compartment, the investment manager uses a combination of market and issuer analysis to identify those securities that offer the best performance in light of interest rate trends. The Compartment's management approach uses strict risk controls. The investment manager considers ESG factors a core element of its strategy by adopting a best in class approach which seeks to invest in securities of issuers with low sustainability risks while avoiding those with high sustainability risks, subject to good governance practices. Activities that adversely affect society or the environment are also avoided. There may be engagement with companies to positively influence ESG practices. For further information, please refer to our exclusion framework in the Responsible Investment policy*, SFDR product category Article 8. The portfolio composition is not constrained relative to the benchmark, so the similarity of the Compartment's performance to that of the benchmark may vary.






Ratings breakdown (% of asset)




Risk Country (% of asset)



Economic sector (% of asset)




Instruments breakdown (% of asset)

FINANCIAL GLOSSARY

SFDR Classification Article 8

Investments that promote environmental and/or social characteristics and may target sustainable investments, provided that the companies in which the investments are made follow good governance practices.

Conversion fee

Fee paid for the transfer of shares of one unit/share class to another unit/share class.

Standard deviation and annualised volatility

Annualised volatility is a risk indicator showing the extent of the price fluctuations of a security or fund unit compared to its average price over a given period. The higher the volatility, the greater the fluctuations.

Inception date

The inception date is the date taken into account for the start of performance calculation. It corresponds to the launch date.

The Compartment may be exposed to the following risks which are not adequately captured by the synthetic risk indicator and may negatively impact its value:

- **Operational risk:** losses resulting from human errors, system failures, incorrect valuation and safekeeping of assets.
- Counterparty risk: losses occur when a counterparty does not honour its obligations related to contracts such as over-the-counter derivatives.

Launch date

The launch date is the date when the sub-fund was activated in its current legal status.

Order deadline

Deadline for remittance of orders to the transfer agent in Luxembourg as set out in the relevant annexes to the prospectus. You may be required to submit your orders to your financial advisor or fund distributor by an earlier cut-off time.

Rating

The rating is a score awarded by rating agencies reflecting their opinion on the creditworthiness of an issuer.

- Financial Derivatives risk: the leverage resulting from derivatives amplifies losses in certain market conditions.

Ongoing Costs
