### Important Information

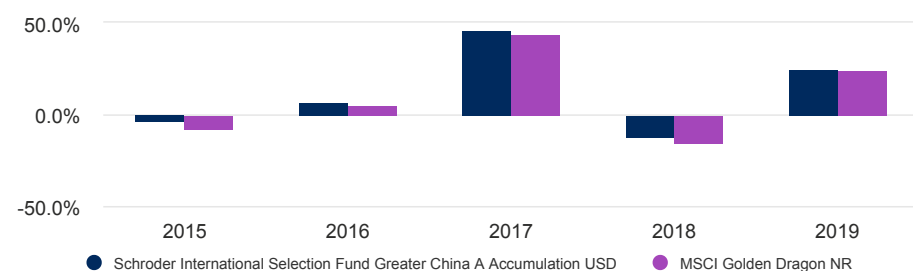

The benchmark has been changed from MSCI Golden Dragon Index to MSCI Golden Dragon Index Net TR on 02.04.2013. The full track record of the previous benchmark has been replaced with the new one. 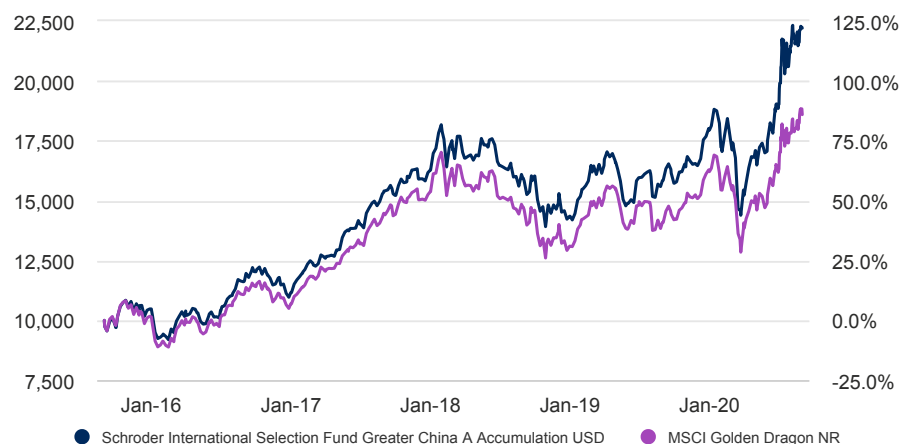

### Return of USD 10,000



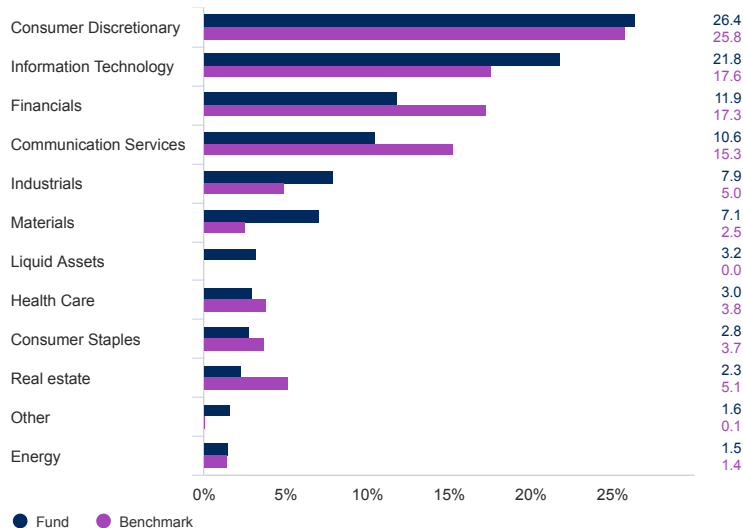

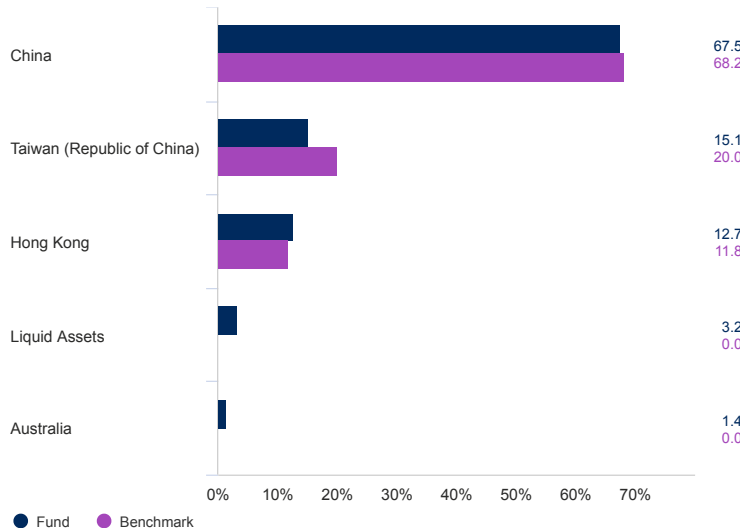
