

# Fidelity Funds – Global Financial Services Fund

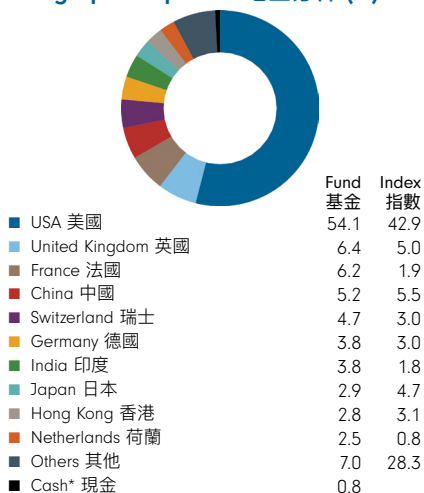

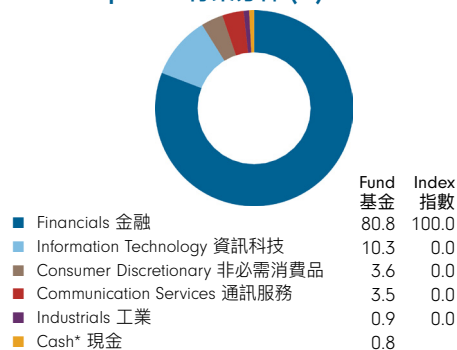
### Geographic Exposure 地區分佈 (%)
