As the Sub-Fund may invest in A Shares through ELIs, the Sub-Fund is therefore exposed to the risks relating to investment in ELIs: (i) Credit risk: If any one of the ELIs issuers fails to perform its obligations under the ELIs, the Sub-Fund may suffer losses potentially equal to the full value of the instrument issued by the relevant issuer. Any loss would result in the reduction in the Net Asset Value of the Sub-Fund and impair the ability of the Sub-Fund to achieve its investment objective.
- (ii)Illiquidity risk: There may not be an active market for those ELIs which are not listed or quoted on a market. Even if the ELIs are quoted, there is no assurance that there will be an active market for them. Therefore investment in ÉLIs can be highly illiquid.
- (iii)Qualified foreign institutional investors ("QFII") risk: The Sub-Fund's exposure to the PRC market via ELIs depends on the ability of the QFII to buy and sell A Shares. - 6. The Sub-Fund is subject to PRC tax risk. There are risks and uncertainties associated with the current PRC tax laws, regulations and practice in respect of capital gains realised via Shanghai and Shenzhen Connect or ELIs on the Sub-Fund's investments in the PRC. Any future changes in the taxation policies in respect of QFII's or the Sub-Fund's investment in A shares in the PRC will impact on the Sub-Fund's returns. It is possible that any future announcement by the PRC tax authority may subject the Sub-Fund to unforeseen tax obligations, which may have retrospective effect.
- The Manager will normally make distributions out of net income received or receivable. However, in the event that the net income is insufficient to pay the distributions that it declares, the Manager may also, in its absolute discrétion, determine that distributions be paid out of capital, or the Manager may, in its discretion, pay distributions out of the gross income while charging/paying all or part of the fees and expenses to/out of capital, resulting in an increase in distributable income for the payment of distributions and therefore, the Sub-Fund may effectively pay distributions out of capital. This may reduce the capital available for investment in future and may constrain capital growth.
- 8. Investors should be aware that in circumstances where distributions are paid out of capital or effectively out of capital, this amounts to a return or withdrawal of part of the amount investors originally invested or from any capital gains attributable to that original investment. Any distributions involving payment of distributions out of capital or payment of distributions effectively out of capital (as the case may be) may result in an immediate decrease in the Net Asset Value per Unit of the relevant class.
- The Manager will declare an indicative per annum distribution rate for the relevant class of Units at the beginning of each calendar year. INVESTMENT OBJECTIVES AND POLICIES

The BOCIP China Value Fund seeks to achieve long term capital growth by investing primarily in securities issued by or linked to companies which activities and business are closely related to the economy of the PRC

The Manager will consider investment opportunities in all market capitalization ranges. The Manager would place particular emphasis on and will invest at least 70% of its non-cash assets in securities that are, in its opinion, with attractive values and investment in such securities will achieve the investment objectives of the Sub-Fund. Stock selection is based on "intrinsic valuation matrix" which seeks to identify companies with growth potentials, good fundamentals and/or attractive valuations. Fundamental factors may include business strategy, management strength and financial position. The Sub-

Fund will mainly invest in Hong Kong-listed stocks, H shares, shares of red-chip companies (directly and/or indirectly through investments in SFC authorised collective investment schemes ("CISs") (including CISs managed by the Manager)) and/or ETFs listed on the Stock Exchange of Hong Kong Limited ("SEHK") (including ETFs managed by the Manager). The Sub-Fund may also invest (a) up to 20% of its Net Asset Value in A shares ((i) directly through the Shanghai-Hong Kong Stock Connect and/or Shenzhen-Hong Kong Stock Connect; and/or (ii) indirectly through investment in ELIs (which may take the form of notes, contracts or other structures) issued by institutions or their affiliates with QFII status in the PRC, ETFs listed on the SEHK (including ETFs managed by the Manager) and/or SFC authorised CISs (including CISs managed by the Manager)); and/or (b) up to 15% of its Net Asset Value in B shares listed on the stock exchanges in Mainland China. The aggregate exposure to the A shares and B shares market will not exceed 20% of the Sub-Fund's Net Asset Value.

♦ The Sub-Fund is approved as "Eligible Collective Investment Scheme" under "Capital Investment Entrant Scheme" ("CIES") of Hong Kong Special Administrative Region ("HKSAR"). MANAGER'S COMMENT^{##}

On Market

Un Market China's third quarter GDP grew 4.9% over last year, versus the 3.2% growth in the second quarter. The economic recovery trend could also be seen from the continuously strong export and industrial production figures. On the other hand, import growth surged to 13.2% in September from -2.1% in August while retail sales growth increased to 3.3% from 0.5%. Domestic tourism revenues during the National Day Golden Week recovered to 69.9% of last year's level, which marked great improvement from the Dragon Boat Festival and the Labour Day holiday. Moreover, the daily retail sales during the golden week increased 4.9%. Domestic consumption is joining the external demands in lifting the economy. The market now eyes on the proposals of the 14th Five-Year Plan being accessed in late October. It should show how Beijing plans to deal with the deteriorating Sino-US relation and the global economic downturn. Major mainland equity indices staged a rebound after the National Day Golden Week, but just closed slightly higher or flattish by end October. The rally of "new infrastructure" and renewable energy related sectors, revived investor interests on the traditional banking and insurance sectors, and positive macro releases were the major uplifts during most of the month. But the upward momentum was largely discounted by month-end after another round of overseas sell-offs triggered by renewed lock-down measures, anticipation of the 19th CPC's fifth plenary session as well as the upcoming presidential election in U.S. The relatively tech-savy ChiNext Index posted a 3.1% gain in October and outperformed large-cap dominant mainland peers like Shanghai Composite Index, which only edged 0.2% higher for the month. Hang Seng H-share Index gained 3.8% in October, mainly led by the advance of several Communication Services, Consumption Discretionary, and Financial Services related heavyweights. **On Portfluin**

On Portfolio

The Sub-Fund registered a positive return in October. The surging cases of COVID-19 in Europe and in the US, and the uncertainty in the US presidential election have continued to suppress investors' risk appetite. Revisions and earnings surprise were the key return drivers in the month. Overall, we saw volatility of both onshore and offshore markets staying at relatively lower levels during the period. Looking ahead, the elevated geopolitical tensions and the resurgence of COVID-19 in major economies will remain our major concerns in the quarter. In any case, prudent stock selection and dynamic cash management will continue to be the construction of the Sub-Fund to be the core strategy of the Sub-Fund.
