## AUGUST 2020 / FACTSHEET

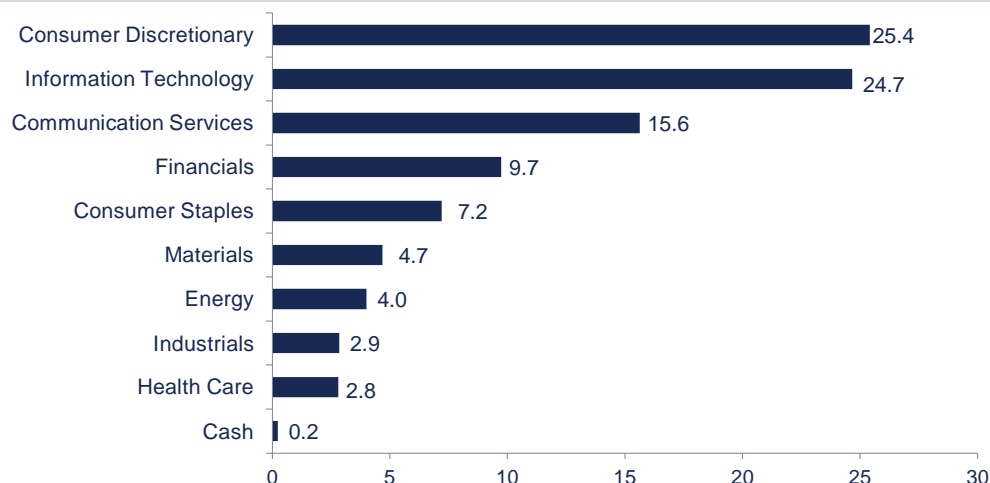

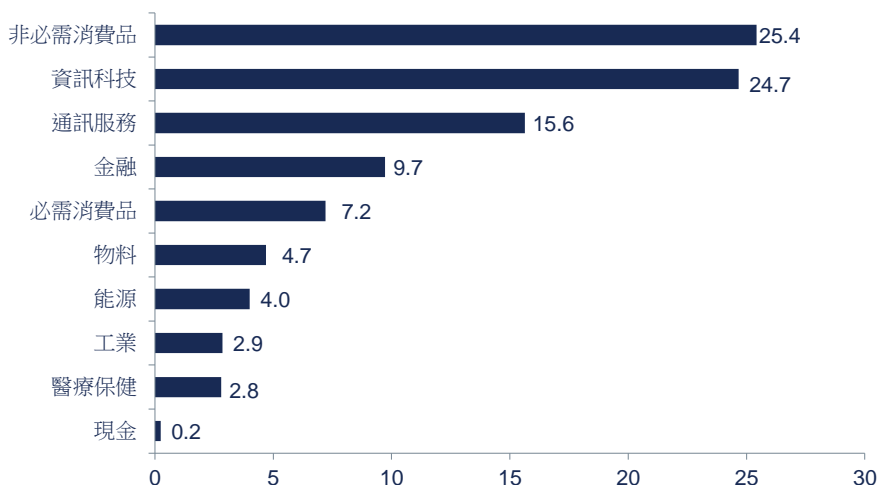
