Important Information

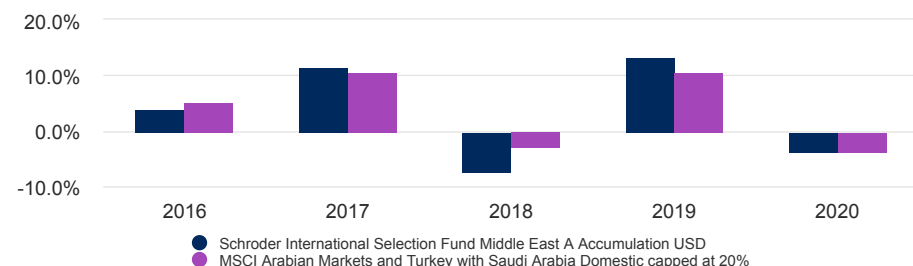

The constituent country weights in the benchmark were rebalanced on 30.09.2009 as follows [Country weight% (previous weight)]: Turkey 23%(19%), Saudi Arabia 20%(10%), Kuwait 20%(17%), UAE 10%(5%), Egypt 9%(5%), Qatar 6% (5%), Lebanon 2%(1%), Other countries 10% (8%) and Israel 0% (30%). The benchmark has been changed from MSCI Arab Mkts & Turkey with Saudi Arabia capped at 20% to 80% MSCI Arab Mkts & Turkey + 20% S&P Saudi Arabia Large / Mid Cap on 01.10.2010, and back to MSCI Arabian Mkts & Turkey with Saudi Arabia Domestic Capped at 20% on 01.09.2012. The full track record of the previous two indexes has been chain linked to the current one.

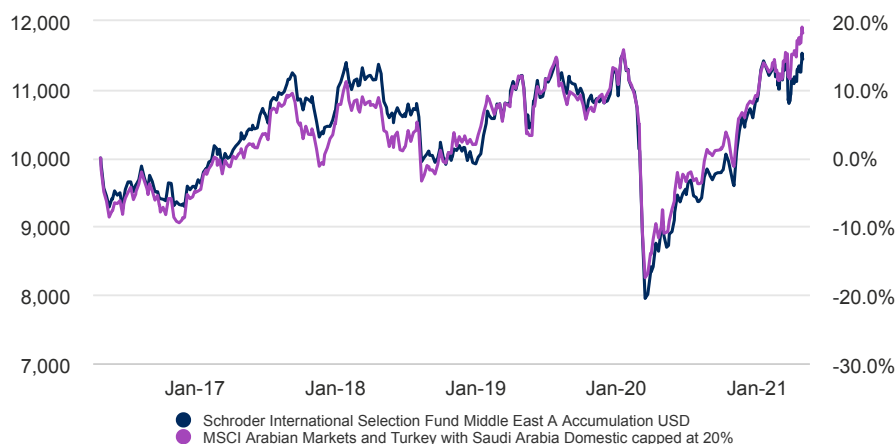

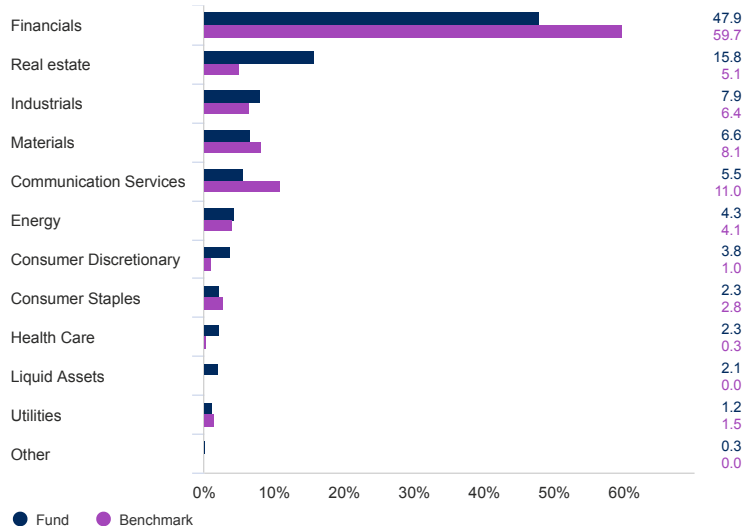

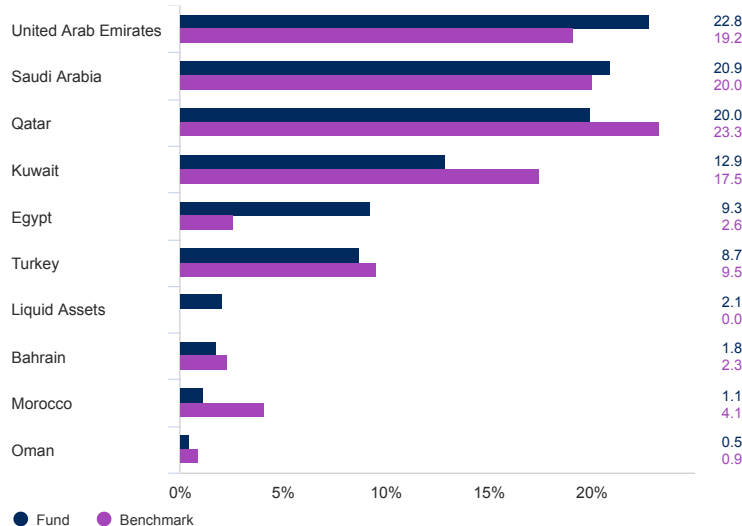

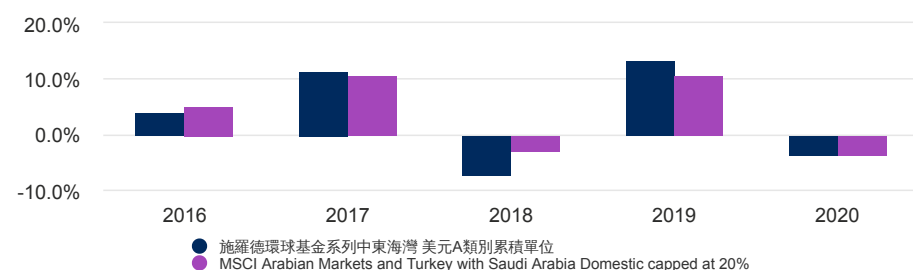

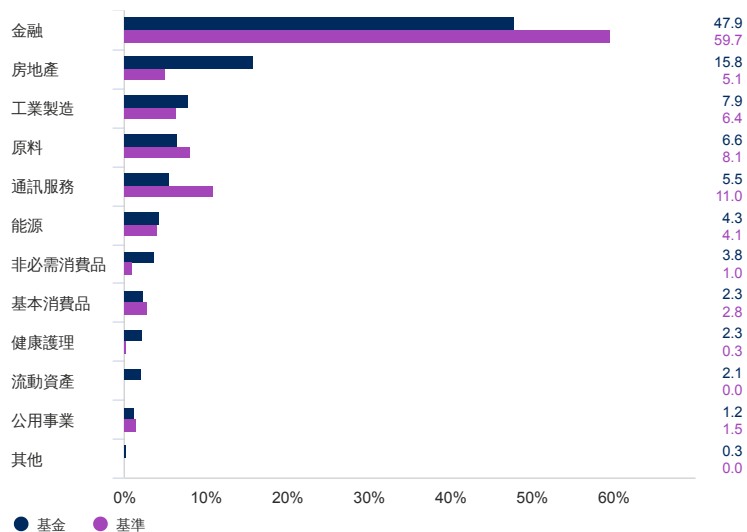

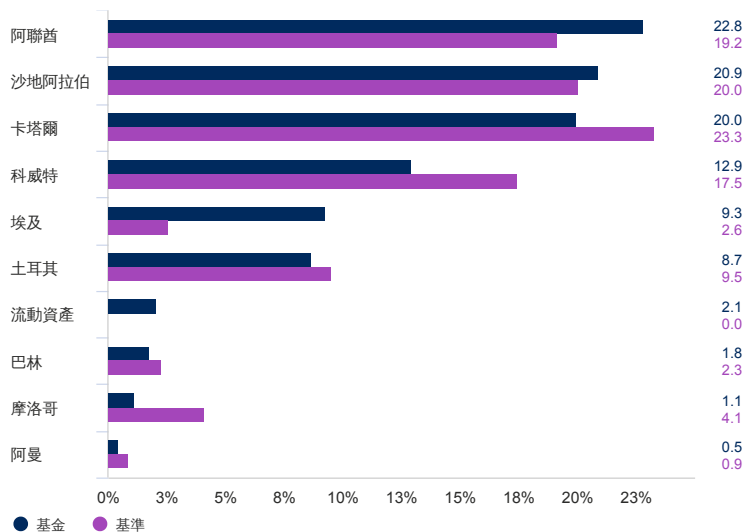
