WHAT IS THIS PRODUCT?

Type: KraneShares ICBCCS S&P China 500 UCITS ETF (the "Fund") is a sub-fund of KraneShares ICAV, an Irish collective asset-management vehicle ("ICAV") constituted as an umbrella fund with segregated liability between sub-funds with registration number C181441 and authorised by the Central Bank of Ireland as a UCITS pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. Segregated liability between sub-funds means that the assets and liabilities of each sub-fund are segregated by law, so that an investor should have no claims over the assets of a sub-fund in which they do not own shares. The prospectus and periodic reports are prepared for KraneShares ICAV at umbrella level. Shares in the Fund may not be converted into shares in another sub-fund or from one share class in the Fund into another share class within the same sub-fund.

Objectives: The Fund seeks to deliver the performance corresponding generally to the price and yield performance of the investable universe of the largest and most liquid publicly traded Chinese companies.

Investment Policy: The Fund is passively managed and will seek to achieve its objective by tracking the performance of the S&P China 500 Index (the "Index") as closely as possible. The Index comprises 500 of the largest, most liquid Chinese Companies, weighted by float-adjusted market capitalisation, while approximating the sector composition of the broader Chinese equity market. The Fund seeks to hold all the securities of the Index with the approximate weightings that they have in the Index. The Fund seeks to create a near mirror image of the Index but may, in certain circumstances purchase securities that are not included in the Index. Although the Index is generally well diversified, because of the market it reflects, depending on market conditions, the Fund may, in order to track the Index accurately, hold positions in individual constituents of the Index up to 20% of the Fund's Net Asset Value. The Fund does not intend to use financial derivative instruments.

Save in exceptional circumstances, the Fund will only issue and redeem shares of the Fund ("Shares") to certain institutional investors. However, other investors may purchase or sell Shares through brokers on one or more stock exchanges. The Shares trade on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund.

The Fund may engage in securities lending but does not intend to use repurchase agreements or total return swaps. The Fund may invest up to 10% of its net asset value in other regulated collective investment schemes, including other exchange traded funds.

Shareholders may redeem Shares on any business day (a day on which commercial banks are open and settle payments in London, New York, Shanghai and Hong Kong, including days on which such commercial banks are open only half a day) and any other day at the directors' discretion provided Shareholders are notified in advance. The Fund intends to make dividend payments on an annual frequency which may be paid from either the Fund's net income and / or its capital. The base currency of the Fund is US Dollar and the class currency of this Class is U.S. Dollar.

Intended Retail Investors: Typical investors in the Fund are expected to be investors who want to take long term exposure to the performance of large China based companies and are prepared to accept the risks associated with an investment of this type. The investor should be prepared to bear losses.

Term: The Fund has no maturity date. The Management Company is not entitled to terminate the Fund unilaterally. The Fund may be terminated unilaterally by KraneShares ICAV under certain circumstances as set out in the prospectus for KraneShares ICAV.

WHAT HAPPENS IF KRANESHARES ICAV IS UNABLE TO PAY OUT?

SEI Investments – Depositary and Custodial Services (Ireland) Limited (the “Depositary”) will perform safekeeping duties for the Fund’s assets. In the event of the insolvency of the Manufacturer (KraneShares ICAV), the Fund’s assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary’s insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from its negligent, or intentional failure properly to fulfil its obligations.
