

Important Notes 重要提示

- 1 Manulife Advanced Fund SPC - China A Segregated Portfolio (the "Fund"), which is denominated in United States Dollars ("USD") rather than Renminbi ("RMB"), uses a USD QFII quota to primarily invest directly in RMB-denominated China A-shares.
- 2 RMB is not freely convertible and is subject to exchange controls and restrictions. There is no guarantee that RMB will not depreciate. The fund seeks to achieve its investment objective by investing primarily (i.e. not less than 70% of its net assets) in companies listed on the A-Share markets of the Shanghai Stock Exchange and/or the Shenzhen Stock Exchange.
