- The Fund invests primarily in equities and equity-related securities of companies incorporated in, or exercising the predominant part of their economic activity in, countries which are members of the Association of South-East Asian Nations (ASEAN), or quoted or traded on the stock exchanges in those countries.
- The Fund is subject to risks, such as investment, equities and equity-related securities, liquidity, counterparty, currency risks and the risks of investing in small and mid-capitalisation companies.
- 3. The Fund's investment may be concentrated in the markets in ASEAN and the value of the Fund may be more volatile. 
