## What is this product?

**Type:** Mutual fund (UCITS)

**Term:** Recommended minimum holding period: 5 years

**Objective:** The fund is an equity fund which invests in both Swedish and foreign stock markets, but no more than 60 percent of the fund may be invested outside Sweden. The fund may invest in other funds and in bank deposits. Derivative instruments may be used to make the management of the fund more efficient.

The fund's objective is to achieve a return in excess of its benchmark, by using a well diversified portfolio.

The fund is actively managed. Deviations from its benchmark can vary over time, please read more in the fund's information brochure or its annual report for historical variations. The fund invests in companies with high ESG grades (environment, social factors and governance). The fund managers use fundamental analysis of, mainly large and midcap companies, in order to take active positions within the funds risk limits. Allocations between countries and sectors may be adjusted on the basis of updated assessments.

The fund is using certain sustainability criterias. Please, read more on our website or in the fund's information brochure for a complete information regarding our sustainable investments.

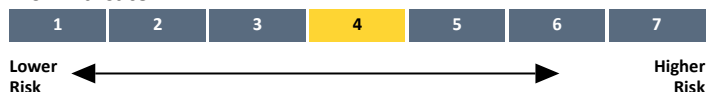
We compare the fund's performance with a benchmark consisting of 60 percent SIXRX and 40 percent MSCI ACWI NR (from 1 November 2022; previously MSCI ACWI ESG Leaders NR). The fund does not distribute dividends.

**Intended Retail Investor:** This fund may be appropriate for investors who plan to retain their investment for at least five years and who understands that the value of the fund can increase as well as decrease and it is not for certain that the invested amount can be recovered. There are no prior knowledge of financial markets nor experience of mutual funds necessary to be able to invest in the fund.

## What are the risks and what could I get in return?

### Risk Indicator



**The risk indicator assumes you keep the product for 5 year(s). This product has no maturity date.**

We have classified this product as 4 out of 7. This is a medium risk class, which entails a medium risk of both increases and decreases in unit value.

The risk indicator illustrates how much the fund's value has fluctuated over the past ten years.

Category 1 (lower risk) does not mean that a fund is risk-free. A fund may move along the scale over time, to both the right and

the left. This is because the indicator is based on historical data, which are no guarantee of future risks/rewards. Even if the fund is in the lowest risk class you can lose money, as no investments are entirely risk free.

### Risks not covered by the risk indicator

### Performance Scenarios

### What are the costs?

The tables show the amounts that are taken from your investment to cover different types of costs. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for different holding periods given the moderate scenario. The figures assume you invest SEK 100,000. The figures are estimates and may change in the future. You should note that these costs are paid by the Company whereas the return that you may receive will depend on the Company's share price performance.
