**Investment Objective & Policy**

The Fund aims to increase the value of your investment over the long term. It looks to outperform the S&P500 Index after the deduction of charges. The Fund invests at least two-thirds of its assets in shares of American (US) companies. The Fund may also invest in asset classes and instruments different from those stated above.


The Fund is actively managed in reference to the S&P500 Index. The index is broadly representative of the companies in which the Fund invests, and provides a suitable target benchmark against which Fund performance will be measured and evaluated over time. The fund manager has discretion to select investments with weightings different to the index, and that are not in the index, and the Fund may display significant divergence from the index.

Deviations from the index, including guidelines on the level of risk relative to the index, will be considered as part of the fund manager's risk monitoring process, to ensure the overall level of risk is broadly consistent with the index. In line with its active management strategy, there may be significant deviation from the index.
