## Important note to Hong Kong investors

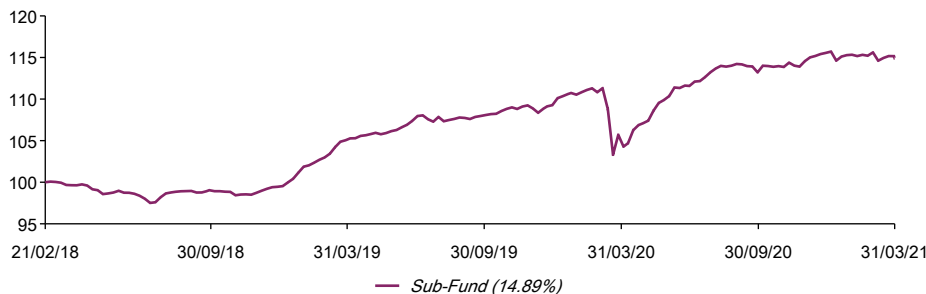

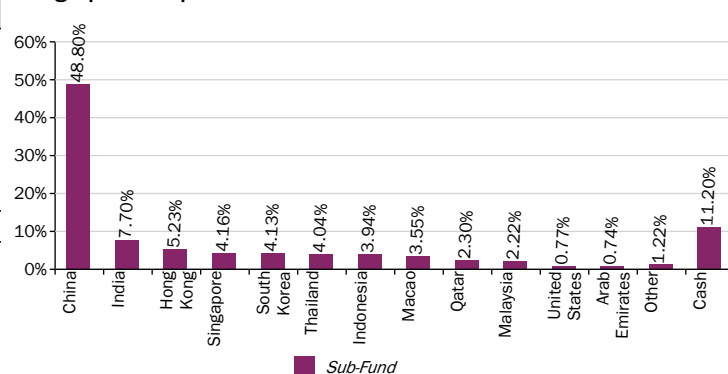
