WHAT IS THIS PRODUCT?

Barings German Growth Trust is constituted in the form of a unit trust. It is domiciled in the United Kingdom and its home regulator is the Financial Conduct Authority.

OBJECTIVES AND INVESTMENT STRATEGY

Objectives

To achieve capital growth by investing in Germany.

Strategy

The Trust will seek to achieve its investment objective by investing at least 75% of its total assets directly and indirectly in equities and equity related securities of companies incorporated in, or exercising the predominant part of their economic activity in Germany, or quoted or traded on the stock exchanges in Germany.

For the remainder of its total assets, the Trust may invest directly and indirectly in equities and equity-related securities outside of Germany as well as in fixed income and cash.

In order to implement the investment policy the Trust may gain indirect exposure through American depositary receipts, global depositary receipts and other equity related securities including participation notes, structured notes, equity-linked notes and debt securities convertible into equities. The Trust may also obtain indirect exposure through investments in collective investment schemes (including collective investment schemes which are managed by the Manager or an associate of the Manager) and other transferable securities.

From time to time and in particular during periods of uncertain or volatile markets, the Manager may choose to hold a substantial proportion of the property of a Trust in money-market instruments and/or cash deposits.

The Trust adheres to the investment restrictions required to qualify as "equity fund" pursuant to section 2 paragraph 6 German Investment Tax Act (GITA) and continuously invests more than 50% of its net asset value in equity participations within the meaning of section 2 paragraph 8 GITA.

Subject to the above, the Trust may invest in any country and in securities issued by companies of any market size, of any industry or sector (as the case may be) in such proportions as the Investment Manager deems appropriate.

The Trust may also use derivatives including futures, options, swaps, warrants and forward contracts for efficient portfolio management (including hedging).

USE OF DERIVATIVES / INVESTMENT IN DERIVATIVES

The Trust's net derivative exposure may be up to 50% of the Trust's Net Asset Value.

WHAT ARE THE KEY RISKS?

1. Investment risk

• The Trust's investment portfolio may fall in value due to any of the key risk factors below and therefore your investment in the Trust may suffer losses. There is no guarantee of the repayment of principal.

2. Risks of investment in equities and equity-related securities

- The Trust's investment in equity securities is subject to general market risks, whose value may fluctuate due to
 various factors, such as changes in investment sentiment, political and economic conditions and issuer-specific
 factors. When the equity markets are extremely volatile the Trust's net asset value may fluctuate substantially.
- The Trust may invest in equity-related securities. These are usually issued by a broker, an investment bank or a company and are therefore subject to the risk of insolvency or default of the issuer. If there is no active market in these instruments, this may lead to liquidity risk. Further, investment in equity-linked securities may lead to dilution of performance of the Trust when compared to the other funds which invest directly in similar underlying assets due to fees embedded in the notes. The aforesaid circumstances may adversely affect the net asset value per unit of the Trust.
- Securities exchanges typically have the right to suspend or limit trading in any instrument traded on that exchange. The governments or the regulators may also implement policies that may affect the financial markets. A suspension could render it impossible for the Investment Manager or an underlying fund manager to liquidate positions and thereby expose the Trust to losses and may have a negative impact on the Trust.

3. Investment in small-capitalisation/mid-capitalisation companies

The stock of small-capitalisation and mid-capitalisation companies may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger capitalisation companies in general. Risks include economic risks, such as lack of product depth, limited geographical diversification, increased sensitivity to the business cycle and organisational risk, such as concentration of management and shareholders and keyperson dependence. Shares in smaller companies can be more difficult to buy and sell, resulting in less flexibility, and sometimes higher costs, in implementing investment decisions.

4. Risks associated with investment in a specific country

- The Trust's investments may be concentrated in German markets. The value of the Trust may be more volatile than that of a fund having a more diverse portfolio of investments. The value of the Trust may be more susceptible to adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting a market in the German market.
- In light of ongoing concerns on the sovereign debt risk of certain countries within the Eurozone, the Trust's investments in the region may be subject to higher volatility, liquidity, currency and default risks. Any adverse events, such as credit downgrade of a sovereign or exit of EU members from the Eurozone, may have a negative impact on the value of the Trust.

5. Risks of investing in convertible bonds

Convertible bonds are a hybrid between debt and equity, permitting holders to convert into shares in the company issuing the bond at a specified future date. As such, convertibles will be exposed to equity movement and greater volatility than straight bond investments. Investments in convertible bonds are subject to the same interest rate risk, credit risk, liquidity risk and prepayment risk associated with comparable straight bond investments.


6. Currency risks

The underlying investments of the Trust may be denominated in currencies other than the base currency of the Trust. Also, a class of units of the Trust may be designated in a currency other than the base currency of the Trust. The net asset value of the Trust may be affected unfavourably by fluctuations in the exchange rates between these currencies and the base currency and by changes in exchange rate controls.

7. Risks associated with derivatives

• In adverse situations, the Trust's use of derivatives for hedging and/or efficient portfolio management may become ineffective and the Trust may suffer significant losses. Risks associated with financial derivative instruments include counterparty/credit risk, liquidity risk, valuation risk, volatility risk and over-the-counter transaction risk. The leverage element/component of a financial derivative instrument can result in a loss significantly greater than the amount invested in the financial derivative instrument by the Trust. Exposure to financial derivative instruments may lead to a high risk of significant loss by the Trust.

這是甚麼產品?

霸菱德國增長基金以單位信託基金的形式組成。信託基金設於英國,而其成立地監管機構為英國金融市場行為監管局。

目標及投資策略

目標

透過投資於德國,從而達致資本增長。

策略

信託基金將尋求透過把其總資產最少75%直接及間接投資於在德國註冊成立或進行其主要經濟活動,或在德國的證券交易所上市或買賣的公司的股票及股票相關證券,以達致其投資目標。

至於其總資產的其餘部分,信託基金可直接及間接投資於德國以外的地區的股票及股票相關證券,以及投資於固定收益與現金。

為實施投資政策,信託基金可透過美國預託證券、全球預託證券及其他股票相關證券(包括參與票據、結構性票據、股票掛鈎票據及可轉換為股票的債務證券)取得間接投資參與。信託基金亦可透過投資於集體投資計劃(包括基金經理或基金經理的聯繫人士管理的集體投資計劃)及其他可轉讓證券取得間接投資參與。基金經理可不時及尤其在市況不明朗或波動的期間選擇將信託基金的大部分財產以貨幣市場工具及/或現金存款持有。

1. 投資風險

3. 投資於小型/中型公司的風險

一般而言,小型及中型公司的股票可能有較低流動性,且其價格相對較大型公司的股價於面對不利經濟發展時會更為波動。風險包括經濟風險,例如有關產品深度欠奉、地域分散有限、對業務週期的敏感度較高及組織風險(例如集中管理及依賴股東及主要人員等)。較小型公司的股份可能較為難以買賣,以致執行投資決定時的靈活性較低,並有時可能須承擔較高成本。

4. 投資於特定國家附帶的風險

- 信託基金的投資可能集中於德國市場。相對於投資組合更為多元化的基金,信託基金的價值可能較為波動。信託基金的價值可能較易受到影響德國市場中某一市場之不利經濟、政治、政策、外匯、流動性、稅務、法律或監管事件所影響。
- 鑑於對歐元區內若干國家的主權債務風險的持續關注,信託基金於該地區的投資可能受到較高波動性、流動性、貨幣及違責風險所影響。任何不利事件(例如一個主權國家的信貸評級下降或歐盟成員國退出歐元區)均可能對信託基金的價值構成負面影響。

5. 投資於可換股債券的風險

可換股債券是債務與股票之間的混合體,准許持有人於指定的未來日期轉換為發行債券的公司之股份。因此,可換股債券將面對股本變動及較傳統債券投資承受較大波動性。於可換股債券的投資承受與可比較傳統債券投資相關的相同利率風險、信貸風險、流動性風險及提前還款風險。


6. 貨幣風險

信託基金的相關投資可能以信託基金的基本貨幣以外的貨幣計值。此外,信託基金的單位類別可指定以信託基金的基本貨幣以外的貨幣結算。信託基金的資產淨值可能因該等貨幣與基本貨幣之間的匯率波動及匯率管制的變動而受到不利影響。
