What is this product? 本基金是什麼產品？

First Sentier Asian Property Securities Fund (the "Fund") is a sub-fund of First Sentier Investors Global Umbrella Fund Plc (the "Company"). This is a mutual fund domiciled in Ireland and its home regulator is the Central Bank of Ireland. 首源亞洲房地產基金（「本基金」）乃首源投資環球傘子基金有限公司（「本公司」）之子基金。本基金為以愛爾蘭為註冊地的互惠基金，其主要監管機構為愛爾蘭中央銀行。

Objectives and Investment Strategy 目標及投資策略

The investment objective of the Fund is to achieve a total investment return consistent with income and long term capital growth. 本基金的投資目標為達致相等於收入與長期資本增值的合計投資回報。

The Fund invests primarily (at least 70% of its Net Asset Value) in a broad selection of Asian equity securities or equity-related securities issued by real estate investment trusts or companies that own, develop or manage real property and which are listed, traded or dealt in on regulated markets in the Asian Region. Equity-related securities include warrants, preference shares, rights issues, convertible bonds, depository receipts such as American Depositary Receipts and Global Depositary Receipts, equity linked or participation notes etc. that are listed, traded or dealt on regulated markets. The Fund may not invest more than 15% of its Net Asset Value in aggregate in warrants or equity linked or participation notes. 本基金主要（至少其資產淨值的 70%）投資於範圍廣泛的亞洲股票證券或股票相關證券，該等證券乃由房地產投資信託基金或擁有、發展或管理實質物業的企業發行，並於亞洲區受監管市場上市、買賣或交易。在受監管市場上市、買賣或交易的股票相關證券包括認股權證、優先股、供股、可換股債券、美國預託證券及全球預託證券等託存證券、股票掛鉤或分紅票據等。本基金對認股權證或股票掛鉤或分紅票據的合計投資比例均不得超過其資產淨值的 15%。

The Fund is not subject to any limitation on the portion of its Net Asset Value that may be invested in any one or more emerging markets in the Asian Region or any limitation on the market capitalisation of the companies in which it may invest. 本基金可用以投資於亞洲地區任何一個或多個新興市場的資產淨值部份並不受任何限制，其可投資的公司的市值亦不受任何限制。

Although the Fund has a regional investment universe, the securities selected for investment based on the Investment Manager's approach may at times result in a portfolio that is concentrated in certain countries. 雖然本基金可在區域內進行投資，但按投資經理的方法所挑選供投資的證券可能不時導致投資組合集中於若干國家。

The Fund may only use financial derivative instruments ("FDIs") for purposes of hedging and efficient portfolio management. The Fund will not invest extensively or primarily in FDIs to achieve its investment objective. It is not intended that the Fund will avail of the opportunity to invest in FDIs for investment purposes. 本基金僅可為進行對沖及有效管理投資組合而使用金融衍生工具（「金融衍生工具」）。本基金將不會大量或主要投資於金融衍生工具以實現投資目標。本基金不擬就投資目的而藉機投資於金融衍生工具。

The Fund may invest cash balances in short-term securities listed, traded or dealt in on a regulated market. For defensive purposes during periods of perceived uncertainty and volatility (e.g. market crash or major financial crisis), the Fund may also hold all or part of its assets in debt securities, asset-backed and mortgage-backed securities which must be rated at least investment grade or in the opinion of the Investment Manager to be of comparable quality and which are listed, traded or dealt in on a regulated market. It is currently intended that the Fund's investment in asset-backed securities and/or mortgage-backed securities (if any) will be less than 30% of its Net Asset Value. 本基金可將現金結存投資於在受監管市場上市、買賣或交易的短期證券。在市況有欠明朗或走勢反覆時期（如股災或重大金融危機），為求穩健起見，本基金亦可以債務證券、資產擔保證券及按揭證券形式持有全部或部份資產，該等證券最少須具備投資評級，或投資經理認為質素相若，並在受監管市場上市、買賣或交易。本基金目前計劃將其少於 30% 的資產淨值投資於資產擔保證券及／或按揭證券（如有）。

The Fund is actively managed meaning that the Investment Manager uses its expertise to pick investments rather than tracking the allocation and therefore the performance of the benchmark. The Fund's performance is compared against the value of the following benchmark: FTSE EPRA Nareit Developed Asia Index. Please refer to the Fund's investment policy in the Prospectus for details of the benchmark information. 本基金是主動型管理基金，意指投資經理運用其專業知識挑選投資，而非追蹤基準的配置以及其表現。本基金的表現與以下基準的數值作比較：富時 EPRA Nareit 已發展亞洲指數。請參閱章程所載本基金的投資政策，了解有關基準資料的詳情。

Use of Derivatives 使用衍生工具

The Fund's net derivative exposure may be up to 50% of the Fund's Net Asset Value. 本基金的衍生工具風險承擔淨額最多可達本基金資產淨值的 50%。

What are the key risks? 本基金有哪些主要風險？

- **Investment Risk** – The value of shares in the Fund may fall due to any of the key risk factors below and therefore your investment in the Fund may suffer losses. There is no guarantee of the repayment of principal.

投資風險—本基金所持股票的價值可因以下任何主要風險因素而下跌，因此閣下於本基金的投資或會蒙受損失。概無保證可收回本金。

- **Market Risk** – Certain situations may have a negative effect on the price of shares within a particular market or cause fluctuation of the value of the Fund's investment in equity securities. These may include regulatory changes, political changes, economic changes, technological changes, changes in the social environment, changes in investment sentiment and issuer-specific factors.

市場風險—若干情況可能對特定市場中的股票價格構成負面影響或對本基金於股票證券的投資價值造成波動。這些情況可能包括監管規定的變動、政治變動、經濟變動、科技轉變、社會環境的變動、投資氣氛的變動及發行機構特定因素。

- **Emerging Market Risk** – Investing in emerging markets (countries considered to have social or business activity in the process of rapid growth and development) may involve increased risks and special considerations not typically associated with investment in developed markets. These risks may include liquidity risks, currency risks/control, political and economic uncertainties, legal and taxation risks, settlement risks, custody risks, the likelihood of a high degree of volatility, market suspension, restrictions on foreign investment and control on repatriation of capital.

新興市場風險—投資於新興市場（即社會或商業活動被視為處於高速增長及發展階段的國家）可能涉及投資於較發達市場一般不會涉及的更多風險及特別考慮因素。這些風險可能包括流通性風險、貨幣風險／管制、政治及經濟不確定因素、法律及稅項風險、結算風險、託管風險、出現大幅波動的可能性、市場暫停、外國投資限制及資金匯回管制。

- **Real Estate Fund Risk** – Although the Fund will not invest in real property directly, the Fund may be subject to risks similar to those associated with the direct ownership of real property. Investing in real estate related assets and securities may expose the Fund to additional risks. The value of the Fund may be impacted by operations and management of the underlying properties and changes in economic conditions. Investors should note that the underlying real estate investment trusts ("REITs") of the Fund may not necessarily be authorised by the SFC and the dividend policy of the Fund is not representative of the dividend policy of the underlying REITs.

房地產基金風險—儘管本基金將不會直接投資於房地產，本基金仍可能承受與直接持有房地產有關的近似風險。投資於與房地產相關的資產及證券，可能會使本基金承受額外的風險。相關物業的營運和管理，以及經濟環境的轉變，或會影響本基金的價值。投資者應注意本基金所投資的相關房地產投資信託基金（「房地產投資信託基金」）未必獲證監會認可，而本基金的股息政策亦不代表相關房地產投資信託基金的股息政策。

- **Single Country/Specific Region Risk** – The Fund's investments may be concentrated in a single country or a small number of countries or a specific region. The value of the Fund may be more volatile than a fund having a more diversified portfolio of investments covering multiple countries. The value of the Fund may be more susceptible to an adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting the relevant market.

單一國家／特定地區風險—本基金的投資可能集中於單一國家或少數國家或特定地區。本基金的價值可能較投資組合較為分散並涵蓋多個國家的基金更為波動。本基金價值可能較易受影響相關市場的不利經濟、政治、政策、外匯、流通性、稅務、法律或監管事件影響。

- **Concentrated Risk** – The Fund invests in a relatively small number of companies. It may be subject to greater risk of the Fund suffering proportionately higher loss should the shares in a particular company decline in value or otherwise be adversely affected than a fund that invests in a large number of companies. Although the Fund has a global or regional investment universe, it may at times invest a large portion of its assets in certain geographical area(s) or countries.

集中風險—本基金所投資的公司數目相對較少。倘若某一公司股份價值下跌或受到不利影響，本基金承受虧損比例較大，可能較投資公司數目相對較多的基金承受較大風險。雖然本基金可在全球或地區進行投資，但其有時可能將大部份資產投資於若干地理範圍或國家。

- **Single Sector Risk** – The Fund's investments may be concentrated in a single sector. Investing in a single sector offers the potential of higher returns but the value of the Fund may be more volatile than a fund having a more diversified portfolio of investments.

單一行業風險—本基金的投資可能集中於單一行業。投資於單一行業有可能取得更高回報，但本基金的價值可能較投資組合較為分散的基金更為波動。

- **Small-capitalisation/Mid-capitalisation Companies Risk** – The stock of small-capitalisation/mid-capitalisation companies may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger capitalization companies in general.

中小市值公司風險—一般而言，與大市值公司相比，中小市值公司的股票的流通性可能較低且其價格一般更易受不利經濟發展的影響而大幅波動。

- **Industry or Sector Risk** – The Fund's investments may be concentrated in fast growing economies or limited or specialist sectors. The value of the Fund may be more volatile than a fund having a more diversified portfolio of investments covering different economic sectors.

行業或板塊風險—本基金的投資可能集中於增長迅速的經濟體系、個別或專門行業。本基金的價值可能較投資組合較為分散並涵蓋不同經濟範疇的基金更為波動。

- **Property Securities Risk** – The Fund invests primarily in the shares of companies that are involved in property (like REITs) rather than property itself. The Fund is subject to the risks associated with direct ownership of the property (in addition to securities markets risks). Accordingly, the value of these investments may fluctuate more than actual property.

房地產證券風險—本基金主要投資於涉及房地產的公司股份（如房地產投資信託基金）而非房地產本身。本基金須承受房地產直接擁有權相關風險（除證券市場風險外）。因此，該等投資價值可能較實際房地產的波幅為大。

- **Investments in Other Collective Investment Schemes Risk** – The Fund may be subject to the risks associated with the underlying collective investment schemes. The Fund does not have control of the underlying investments of the collective investment schemes and there is no assurance that the investment objective and strategy of the underlying collective investment schemes will be successfully achieved which may have a negative impact on the Net Asset Value of the Fund. There may also be additional costs involved when investing into these underlying collective investment schemes.

投資於其他集體投資計劃的風險—本基金可能承受與相關集體投資計劃有關的風險。本基金對集體投資計劃的相關投資並無控制權，且概無保證將成功達致相關集體投資計劃的投資目標及策略，此可能對本基金的資產淨值產生不利影響。投資該等相關集體投資計劃可能涉及額外成本。

- **China Market Risk** – The Fund may invest in securities linked to the China markets, including equity linked or participation notes and collective investment schemes in relation to China A Shares. Such investments involve risks associated with investing in the China markets, including liquidity and volatility risk, foreign exchange, currency and repatriation risk, changes in social, political or economic policies, legal or regulatory event and uncertainties with respect to taxation policies. The Fund's investments in the China markets may as a result incur significant losses. Any increased tax liabilities on the Fund may adversely affect the Fund's value. Based on professional and independent tax advice, the Fund does not currently make any tax provision to cover any potential capital gains tax liability in relation to the Fund's investments in securities that are linked to the China markets. If such PRC taxes are imposed on the Fund, the Net Asset Value of the Fund may be adversely impacted and investors may as a result suffer loss.

中國市場風險—本基金可投資於與中國市場掛鈎的證券，包括與中國 A 股有關的股票掛鈎或分紅票據及集體投資計劃。該等投資涉及與投資於中國市場有關的風險，包括流通性及波動風險、外匯、貨幣及匯回風險、社會、政治或經濟政策、法律或監管活動的變動，以及有關稅務政策的不明朗因素。本基金於中國市場的投資可能因此而招致重大損失。本基金的稅項責任如有任何增加均可能對本基金的價值造成不利影響。根據專業及獨立稅務意見，本基金目前並無作出任何稅務撥備，以應付就本基金投資於與中國市場有關連的證券之任何潛在的資本增值稅項責任。倘本基金被施加該等中國稅項，本基金的資產淨值可能會受到不利影響，投資者可能因而蒙受損失。

- **RMB Currency and Conversion Risk** – Renminbi ("RMB") is currently not freely convertible and is subject to exchange controls and restrictions. Non-RMB based investors are exposed to foreign exchange risk and there is no guarantee that the value of RMB against the investors' base currencies (for example HKD) will not depreciate. Any depreciation of RMB could adversely affect the value of investor's investment in the Fund. Although offshore RMB (CNH) and onshore RMB (CNY) are the same currency, they trade at different rates. Any divergence between CNH and CNY may adversely impact investors. Under exceptional circumstances, payment of redemptions and/or dividend payment may be delayed due to the exchange controls and restrictions applicable to RMB.

人民幣貨幣及匯兌風險—人民幣（「人民幣」）目前不可自由兌換，且須受外匯管制及限制所規限。以非人民幣為基本貨幣的投資者須承受外匯風險，且概不保證人民幣兌投資者基本貨幣（例如港元）不會貶值。人民幣的任何貶值可能對投資者於本基金的投資價值造成不利的影響。儘管離岸人民幣(CNH)及在岸人民幣(CNY)為同一貨幣，但兩者以不同匯率交易。CNH 與 CNY 的任何差異可能對投資者造成不利影響。在特殊情況下，支付贖回款項及／或派付股息可能因適用於人民幣的外匯管制及限制而導致有所延誤。

- **Volatility and Liquidity Risk** – The securities in certain markets may be subject to higher volatility and lower liquidity compared to more developed markets. The prices of securities traded in such markets may be subject to fluctuations.

波動及流通性風險—與較發達市場相比，若干市場的證券可能面對較高的波動及較低的流通性。於該等市場買賣的證券價格或會波動。

- **Currency Risk** – The Fund may buy shares denominated in currencies other than the base currency of the Fund and a share class may be designated in a currency other than the base currency of the Fund. The value of shares in the Fund may be affected unfavorably by fluctuations in the exchange rates between these currencies and the base currency of the Fund and by changes in exchange rate controls.

貨幣風險—本基金可能買入以本基金基本貨幣以外的貨幣計價的股票，而股份類別可以本基金基本貨幣以外的貨幣指定。本基金所投資股票的價值可能因該等貨幣與本基金基本貨幣之間匯率的波動以及匯率管控的變動而受到不利影響。

- **Currency Hedged Share Class Risk** – The Fund may issue classes where the class currency is different to the base currency of the Fund. Accordingly the value of an investor's investment may be affected favourably or unfavourably by fluctuations in the

rates of the different currencies. The Fund may create currency hedged share classes to hedge the resulting currency exposure back into the currency of the relevant class. In addition the Fund may invest in assets with various currency denominations other than the base currency, and the Fund may hedge currency exposure due to investing in assets denominated in currencies other than the Fund's base currency.

Whilst these hedging strategies aim to reduce the losses to an investor's investment if the currency of that currency hedged share class or the currencies of the underlying assets which are denominated in currencies other than the Fund's base currency fall against that of the base currency of the Fund the use of hedging strategies may substantially limit investors in the relevant class from benefiting if the currency of that currency hedged share class rises against that of the base currency of the Fund and/ or the currency in which the assets of the Fund are denominated.

Investors should be aware that there may be circumstances in which a hedging transaction may reduce currency gains that would otherwise arise in the valuation of the Fund. The gains/losses on, and the costs of, such hedging transactions will, to the extent permitted by applicable law and regulation, be borne on a pro rata basis by the currency hedged share classes.

Investors in currency hedged share classes should be aware that the currency hedging process for both types of currency hedged share classes may not give a precise hedge. Hedging transactions are designed to reduce, as much as possible, the currency risk for investors. However, there is no guarantee that the hedging will be totally successful and no hedging strategy can eliminate currency risk entirely. Should a hedging strategy be incomplete or unsuccessful, the value of the Fund's assets and income can remain vulnerable to fluctuations in currency exchange rate movements.

Investors in the currency hedged share classes may have exposure to currencies other than the currency of their share class and may also be exposed to the risks associated with the instruments used in the hedging process.

儘管在貨幣對沖股份類別貨幣或以本基金基本貨幣以外貨幣計值的相關資產貨幣兌換成本基金基本貨幣的匯率下跌的情況下，該等對沖策略旨在減少投資者的投資虧損，使用對沖策略可能大幅限制相關類別之投資者於貨幣對沖股份類別貨幣兌換本基金基本貨幣及／或本基金資產計值貨幣的匯率上升的得益。

投資者務請注意，在若干情況下，對沖交易會令本基金估值時原應產生的貨幣收益減少。有關對沖交易的收益／虧損以及成本，在適用法律及規例許可的範圍內，將由貨幣對沖股份類別按比例承擔。

- **Derivatives Risk** – The Fund may use FDIs for purposes of hedging and efficient portfolio management. FDIs that are not traded on an exchange are subject to, among others, liquidity risk (i.e. the risk that the Fund may not be able to close out a derivative position in a timely manner and/or at a reasonable price), counterparty/credit risks (i.e. the risk that a counterparty may become insolvent and therefore unable to meet its obligations under a transaction), valuation risk, volatility risk and over-the-counter transaction risk. The leverage component of an FDI can result in loss significantly greater than the amount invested in the FDI by the Fund. In adverse situations, the use of FDIs may become ineffective in achieving hedging or efficient portfolio management and may lead to a high risk of significant losses by the Fund.

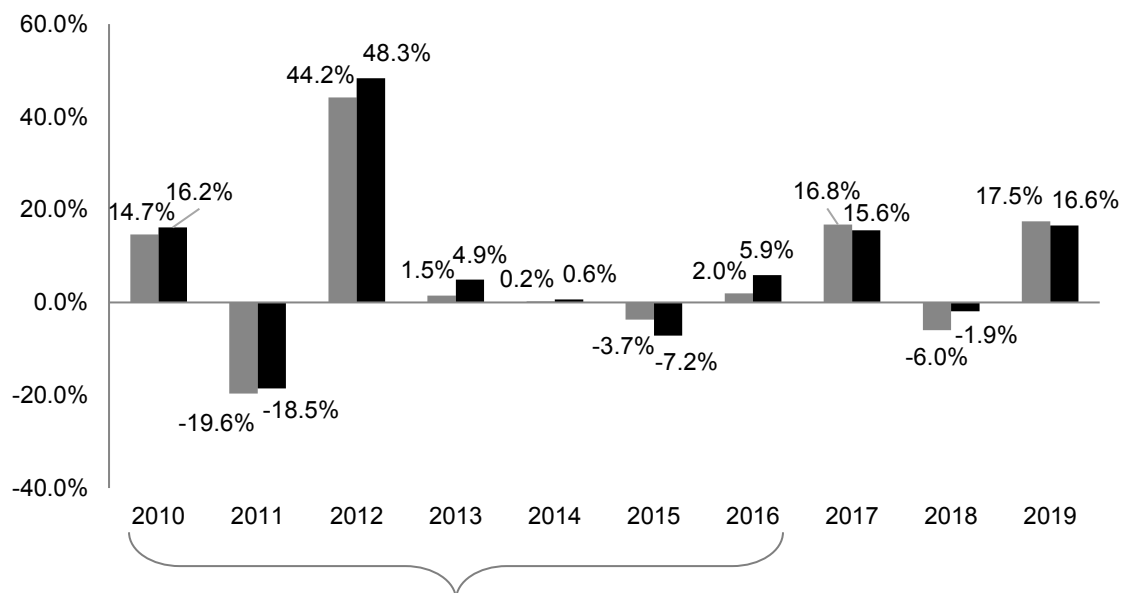

- **Risks associated with distributions or paying fees and expenses out of capital** – (i) Payment of dividends out of capital or (ii) payment of fees and expenses out of capital to increase distributable income amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any such payments or distributions involving payment of dividends out of the Fund's capital or payment of dividends effectively out of the Fund's capital (as the case may be) may result in an immediate decrease of the Net Asset Value per Share.
