



#### INVESTMENT OBJECTIVE

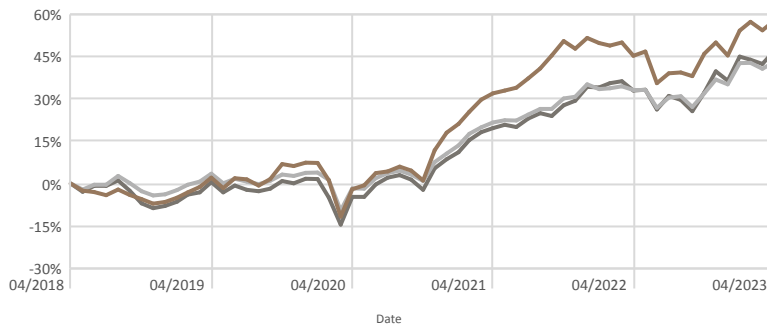
The Centaur BCI Flexible Fund is a flexible portfolio that aims to provide investors with high long term capital growth.

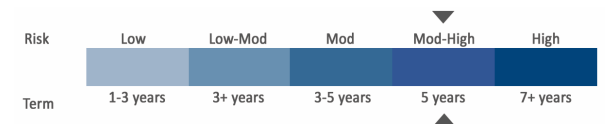

#### Moderate - High Risk
