INVESTMENT OBJECTIVES AND POLICIES

The BOCHK Hong Kong Dollar Income Fund seeks to provide a stable income stream and long-term capital appreciation through investing at least 70% of its non-cash assets in a portfolio which mainly consists of Hong Kong dollar denominated investment grade bonds. The Sub-Fund may invest not more than 30% of its Net Asset Value in debt instruments with loss-absorption features (LAP).

MANAGER'S COMMENT##

On Marko

Hong Kong dollar (HKD) bond markets traded higher in January. Coronavirus outbreak overshadowed trade optimism, spurring concerns over global growth outlook. In tandem with its U.S. counterparts, bond yields in Hong Kong generally fell. However, front-end interbank borrowing costs stayed hovering at recent highs, as liquidity condition remained tight around the Lunar New Year. Tight liquidity environment, alongside persistent high front-end rates relative to its U.S. peers, fueled supports to HKD, which strengthened beyond the 7.77 level per U.S. dollar. This came despite weak domestic data flows as well as Moody's action to cut Hong Kong's credit rating by one notch to Aa3.

On macro front, while the Hong Kong government planned for a fresh round of welfare packages, the outbreak of Coronavirus dealt another blow the economy, with tourists hotspots closed and individual visitor scheme suspended. The number of inbound visitors tumbled for the Lunar New Year holidays, as compared to last year. In residential housing markets, both primary and secondary transactions picked up before the New Year holidays, but home price generally fell.

On Portfolio

The Sub-Fund delivered a positive return for January. Bond market rally benefited performance alongside steady coupon carry. The outbreak of Coronavirus added uncertainty to global growth. This, together with various domestic factors, should keep bond market volatility high. As a defensive play, we adhere to a short-duration strategy whilst favoring high-quality credits for yield enhancement.
