The Investment Manager believes that companies relevant to this theme are those that rely on or benefit from the development of new products or services, technological improvements and advancements in scientific research relating to: **Genomic Revolution Companies** - the study of genes and their functions and related techniques

**Industrial Innovation Companies -** in energy, automation and manufacturing

**Web x.0 Companies** – the increased use of shared technology, infrastructure and services

**FinTech Innovation Companies** – technologies that make financial services more efficient




