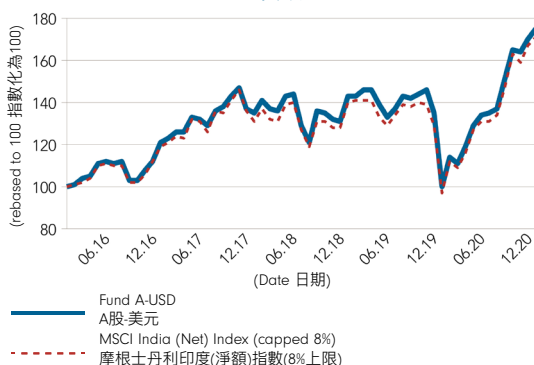

Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to provide long-term growth, principally (i.e. at least 70% (and normally 75%) of the fund's assets) through investment in equity securities of Indian companies listed in India, as well as securities in non-Indian companies which have a significant portion of their activities in India. The income from the fund is expected to be low. (Please refer to the offering document for Investment Objective of the fund)

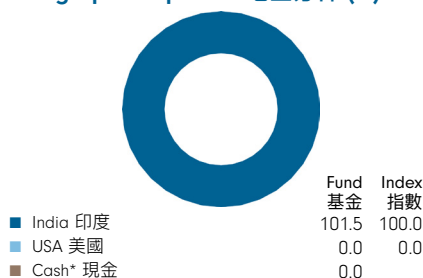

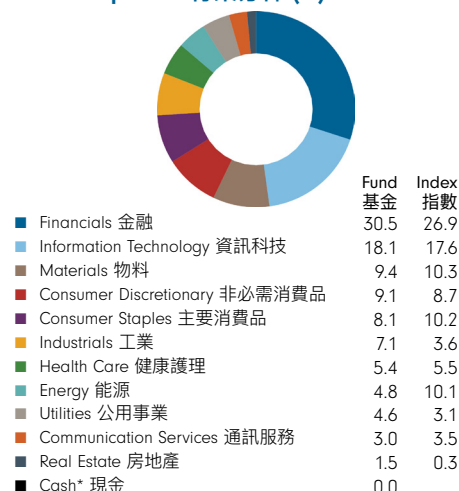
