Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to achieve long-term capital growth principally (i.e. at least 70% (and normally 75%) of the fund's assets) through a focused portfolio invested in companies having their head office or exercising a predominant part of their activity in the US. 


