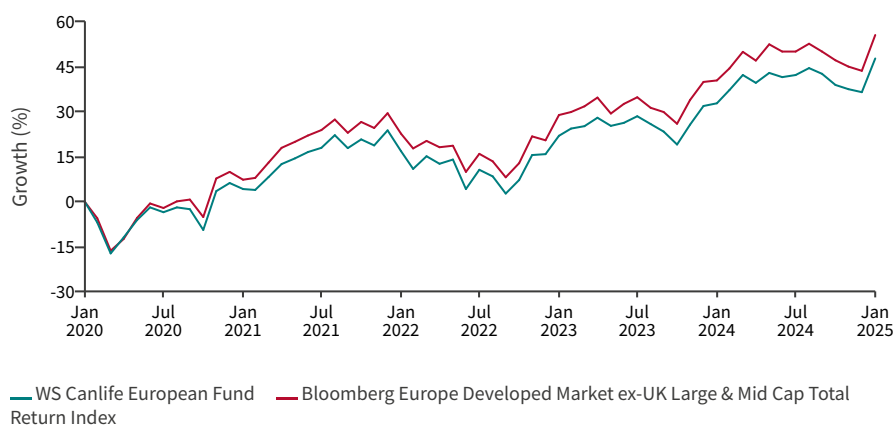


About the fund

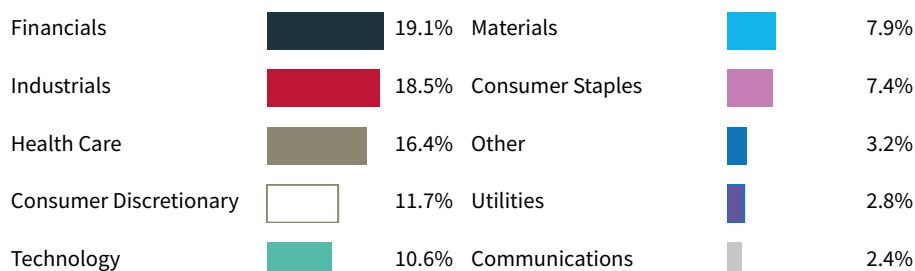

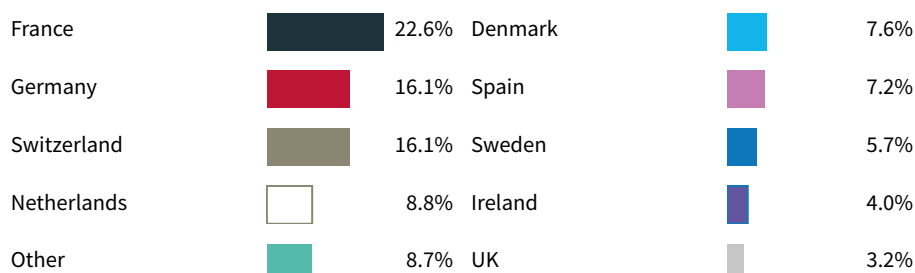
