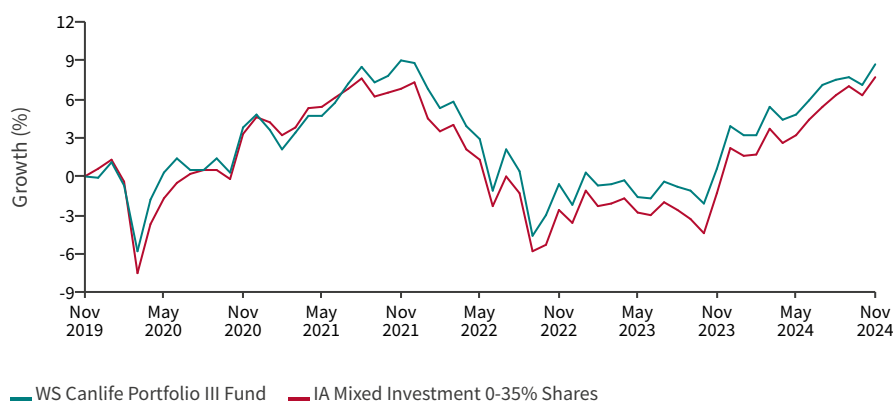


## About the fund

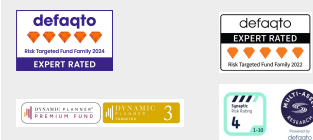
