2. 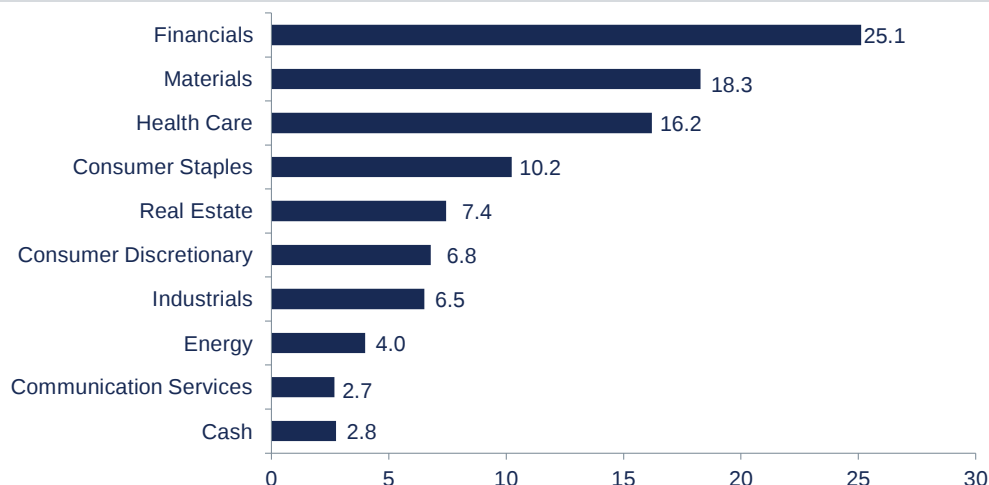

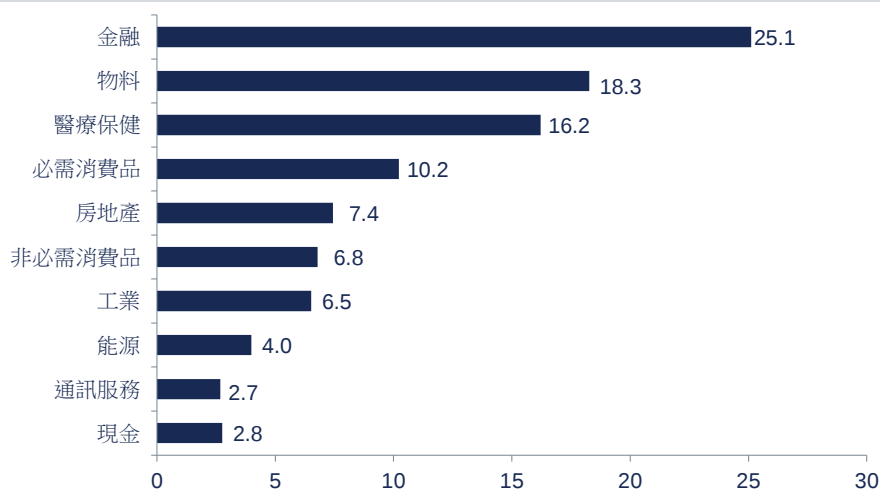
