## What is this product?

**Type**

This is an open ended UCITS fund.

**Term**

There is no maturity date of the fund.

**Investment objective**

The fund aims to provide capital growth by investing in equity and equity related securities of Central and Eastern European companies.

The fund is actively managed and invests at least two-thirds of its assets in equities of Central and Eastern European companies including the markets of the former Soviet Union and the Mediterranean emerging markets.

The fund may also invest in equity and equity related securities of North African and Middle Eastern companies.

The fund typically holds 30-50 companies.

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus).

**Benchmark:** The fund does not have a target benchmark. The fund's performance should be compared against its comparator benchmark, being the MSCI EFM Europe + CIS (E+C) Index Net (TR) index. The fund's investment universe is expected to overlap materially, directly or indirectly, with the components of the comparator benchmark. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the comparator benchmark. The investment manager

will invest in companies or sectors not included in the comparator benchmark in order to take advantage of specific investment opportunities.

The comparator benchmark has been selected because it is representative of the type of investments in which the fund is likely to invest and it is, therefore, an appropriate target in relation to the return that the fund aims to provide.

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

**Dealing Frequency:** You may redeem your investment upon demand. This fund deals daily.

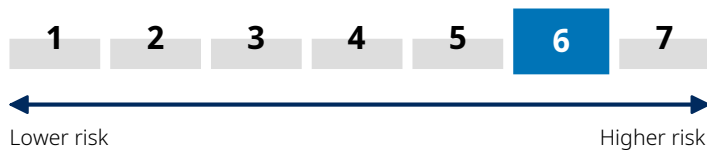
**Distribution Policy:** This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

**Intended retail investor**

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. This product is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

## What are the risks and what could I get in return?

**Risks**

The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the market or because we are not able to pay you.

**Performance Scenarios**

We have classified this product as 6 out of 7, which is the second-highest risk class.

The fund is in this category because it can take higher risks in search of higher rewards and its price may rise and fall accordingly.

**Liquidity risk:** In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares, meaning investors may not be able to have immediate access to their holdings.

## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

If the fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. You are not covered by the Luxembourg compensation scheme.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
