Important Information

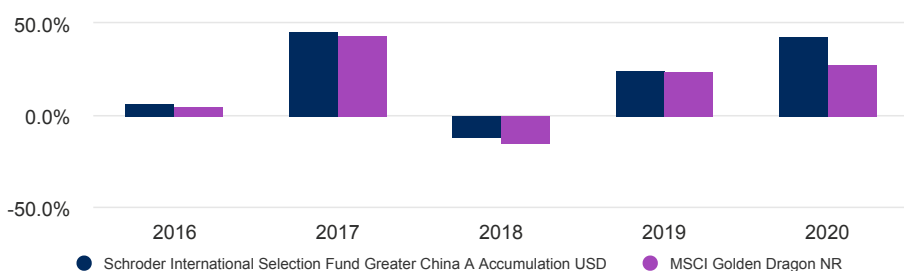
The fund aims to provide capital growth by investing in equity and equity related securities of People's Republic of China, Hong Kong SAR and Taiwan companies.

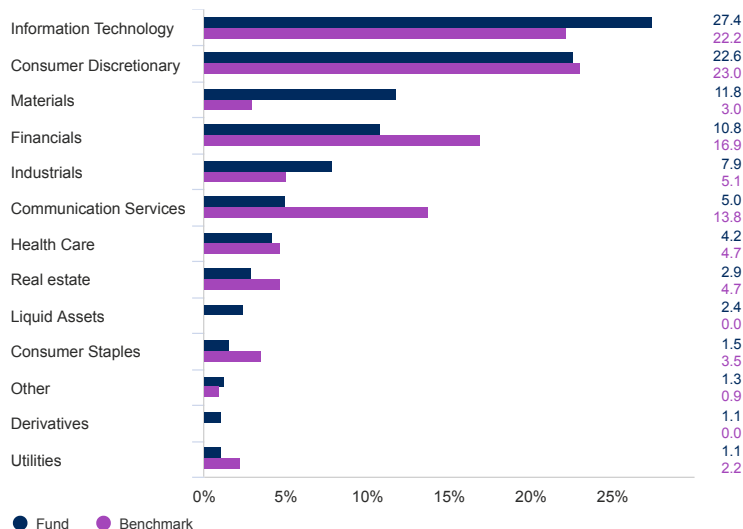

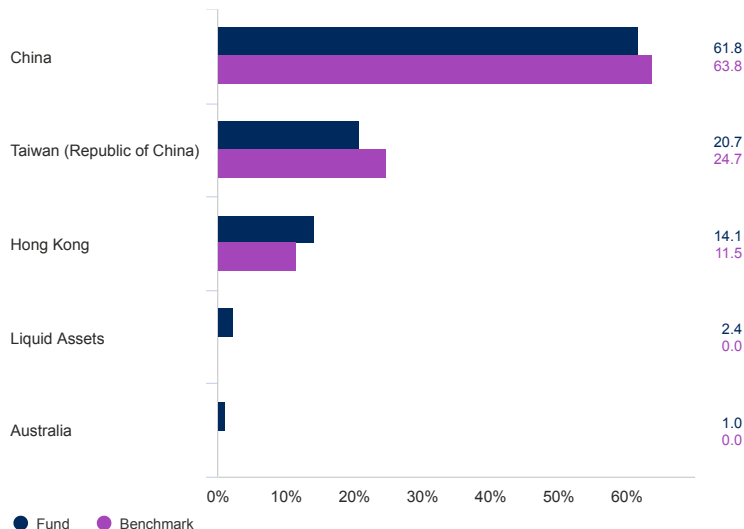

Geographical Breakdown (%)

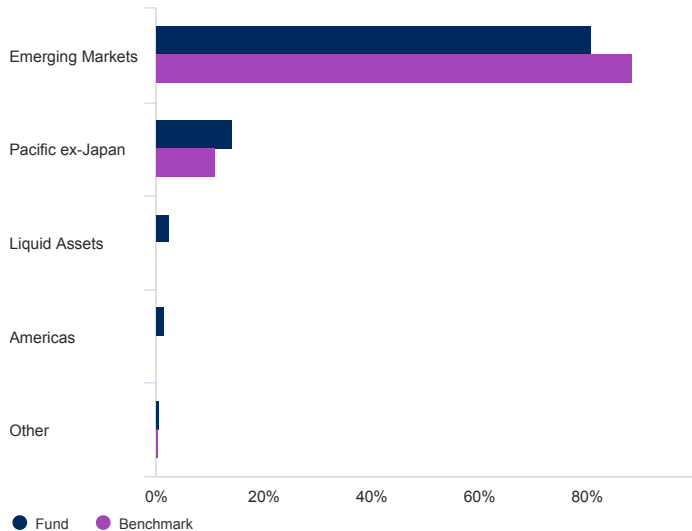

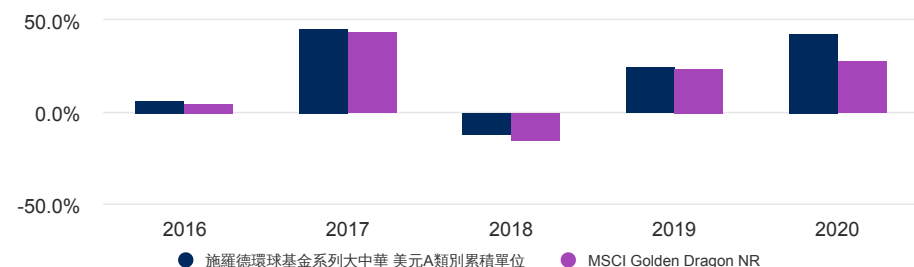

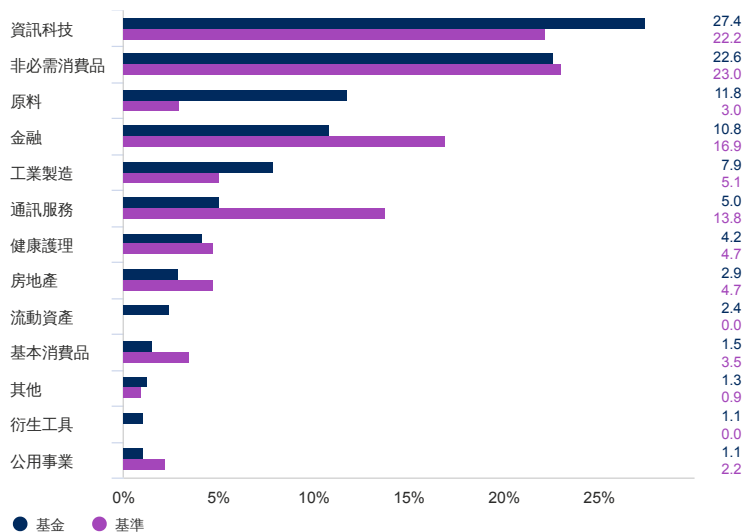

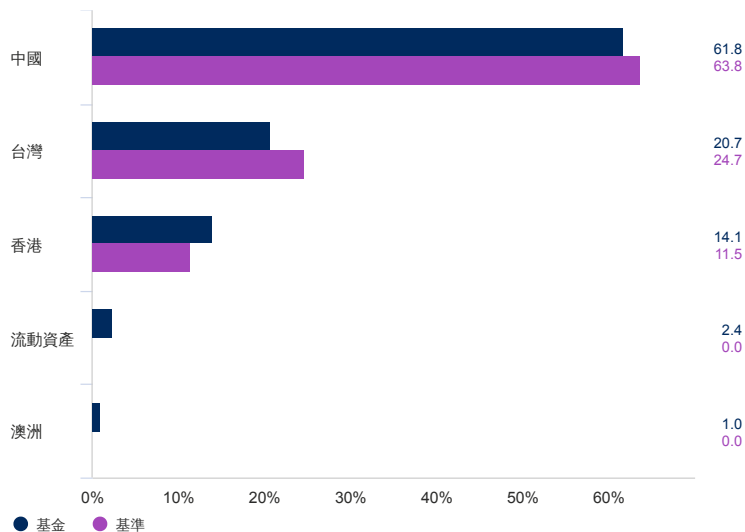

地區資產分佈 (%)

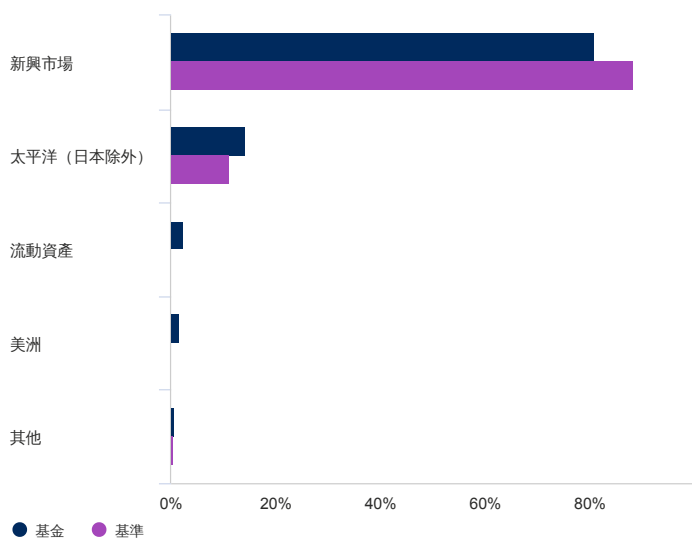
