What is this product?

Type

The product is a share class of FTGF ClearBridge Global Infrastructure Income Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund's investment objective is to provide income comprised of dividends and interest whilst also achieving long-term capital growth.

Investment Policy

- The Fund will invest at least 80% of its net asset value in infrastructure companies via equity and equity-related securities listed or traded on regulated markets in the United States, United Kingdom, Japan, Germany, France, Italy and Canada "OECD G7", and equity and equity-related securities listed or traded on regulated markets of other developed countries and emerging market countries. The Fund may invest (up to 20% of the Fund's Net Asset Value) in equity and equity-related securities listed or traded on regulated markets of emerging market countries.
- The Fund invests in a number of infrastructure sectors such as utilities, transport, community and social infrastructure and communications.
- The Fund will usually invest in a concentrated portfolio, typically 30 to 60 companies.
- The Fund may invest in derivatives to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.
- This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.

• **Benchmark:** FTSE Global Core Infrastructure 50/50 Index

• **Manager's Discretion:** The Fund is actively managed. The Benchmark does not constrain the investment manager's management of the Fund. Over the long term the investment manager seeks to provide an average annual return of the OECD G7 Inflation Index (which return will vary over time) plus 5.5% (gross of fees). The Fund's performance can be measured against its performance target or the Benchmark. There is no guarantee that the investment manager will meet its target, and the target does not take into account the fees charged, which will reduce the Fund's return.

• **Transaction Costs:** The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance.

Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail investor

The Fund may appeal to investors looking to receive income whilst also looking to achieve capital growth by obtaining exposure to global listed infrastructure equities of companies. The Fund will mostly invest in the G7 countries but will invest in other developed countries and emerging markets. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

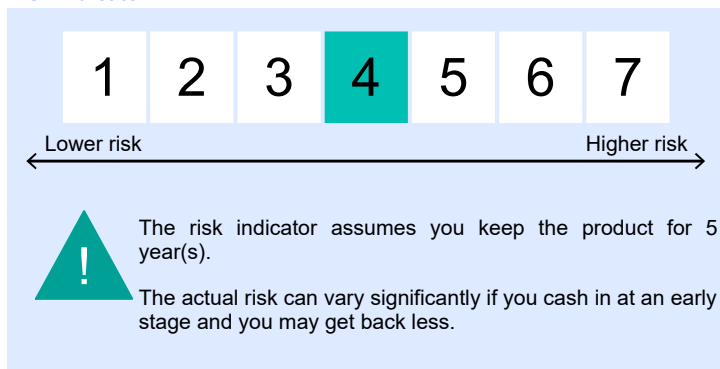

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depository. BNY Mellon SA/NV Dublin Branch, as the appointed depository of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depository or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
