# First Sentier Asian Property Securities Fund

Monthly Fund Factsheet 30 November 2020

-The Fund invests primarily in Asian equity or equity related securities issued by REITs or companies own, develop or manage real property. It may expose to risks akin to direct ownership of real property and value of securities may fluctuate more than actual property. The Fund invests in emerging markets which may have increased risks than developed markets including liquidity risk, currency risk/control, political and economic uncertainties, high degree of volatility, settlement risk and custody risk.
