

# Fidelity Funds – Global Property Fund 富達基金-環球房地產基金

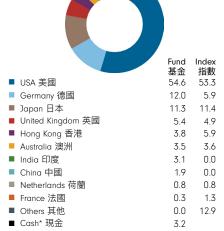
