Objective

To generate income and some growth over the long term (5 years or more) by investing in inflation-linked bonds.

Performance Target: to achieve the return of the Bloomberg World Government Inflation Linked Index (Hedged to GBP), plus 0.5% per annum (before charges). There is no certainty or promise that the Performance Target will be achieved.

The Bloomberg World Government Inflation Linked Index (Hedged to GBP) (the "Index") is a representative index of the global market for inflation-linked bonds.

Portfolio securities

- The fund will invest at least 70% in inflation-linked government bonds (which are like loans to governments that pay a variable interest rate linked to inflation) issued anywhere in the world.
- The fund may also invest in inflation-linked and non-inflation-linked investment grade corporate bonds (which are like loans to companies that pay interest and are typically regarded as having a low default risk) and other bonds issued anywhere in the world. The fund will employ techniques to reduce (hedge) risk related to currency movements on non-sterling bonds.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
