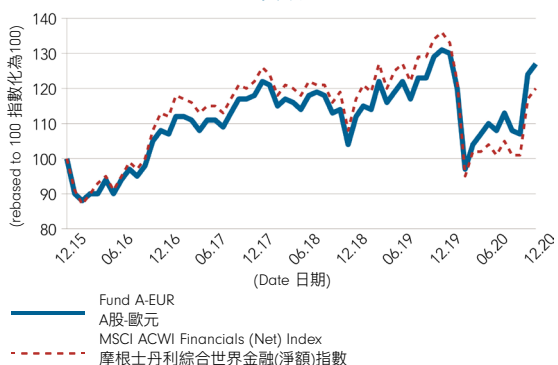
- This fund invests primarily in the equity securities of companies throughout the world which are involved in providing financial services to consumers and industry.

The fund is an Equity fund and aims to provide long-term capital growth, principally (i.e. at least 70% (and normally 75%) of the fund's assets) through investment in equity securities of companies throughout the world that are involved in providing financial services to consumers and industry. 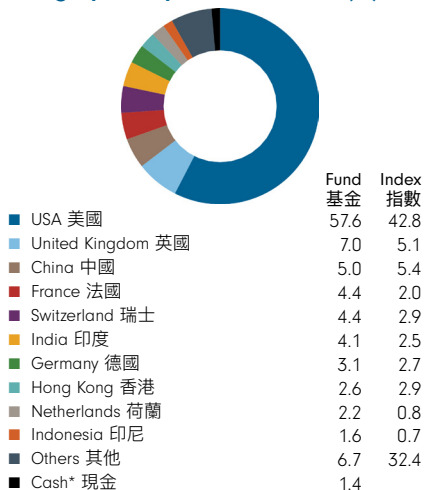

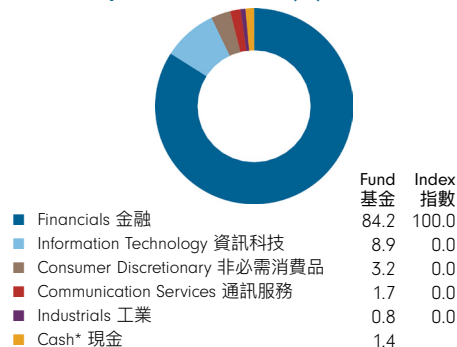
### Geographic Exposure 地區分佈 (%)
