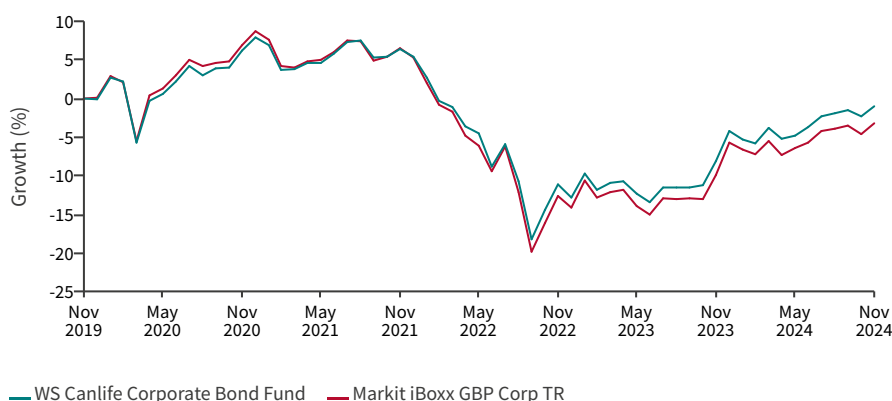


## About the fund
