Monthly Fund Factsheet

The Fund invests primarily in Asian equity and equity related securities issued by REITS or companies own, develop or manage real property. It may expose to risks akin to direct ownership of real property

and value of securities may fluctuate more than actual property. Operation and management of underlying properties and changes in economic conditions may impact its value.

The Fund invests in emerging markets which may have increased risks than developed markets including liquidity risk, currency risk/control, political and economic uncertainties, high degree of volatility, settlement risk and custody risk.
