About The Fund 基金概要

The fund is an Equity fund and aims to provide long-term capital growth with the level of income expected to be low.The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in equity securities of areas experiencing rapid economic growth including countries in Latin America, South East Asia, Africa, Eastern Europe (including Russia) and the Middle East. 
