The Fund aims for medium to long-term capital appreciation by investing in Japanese equities and equity-related instruments.

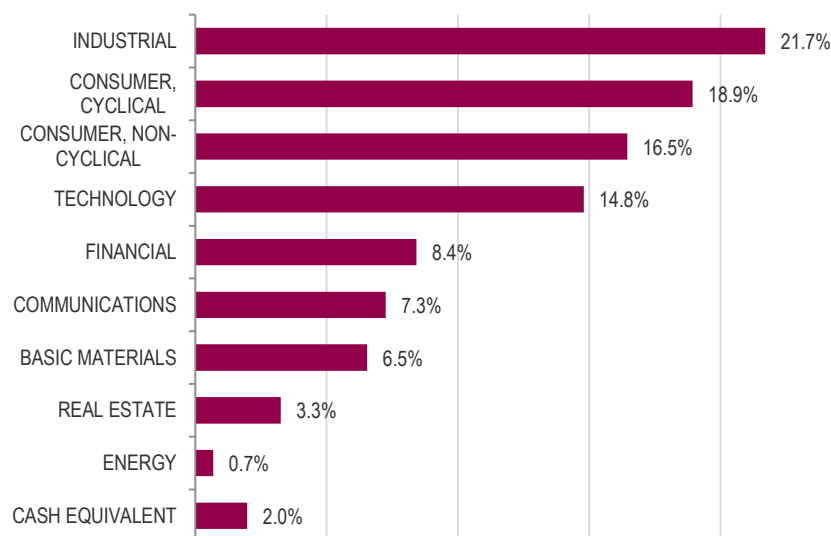
