

Fidelity Funds - Asia Pacific Dividend Fund 富達基金-亞太股息基金

- This fund invests primarily in income producing equity securities in the Asia Pacific region. The fund is subject to equities risk, risk to capital and income, foreign currency risk and valuation risk and risks or investing in emerging markets. Although the fund will generally invest in income-producing securities, it is not guaranteed that all underlying investments will generate income. Higher yields generally mean that there will be reduced potential for capital appreciation for equity securities.


