

# First State China Focus Fund

-The Fund invests primarily in equity or equity-related securities issued by large and mid capitalisation established or having significant operations in China.

- -Investing in mid-capitalisation companies securities may have lower liquidity and their prices are more volatile to adverse economic developments.

board and/or ChiNext market. The Fund may also expose to RMB currency and conversion risk. The Fund may use FDIs for hedging and efficient portfolio management purposes, which may subject the Fund to additional liquidity, valuation, counterparty and over

the counter transaction risks.


