The weighted average credit rating is derived by taking the weighted average of the credit rating for each underlying bond in the portfolio. The weighted modified duration represents the average modified duration of the portfolio of the underlying bonds weighted by reference to their market value.

Allocation percentage is rounded to the nearest one decimal place and the total allocation percentage may not add up to 100%
