

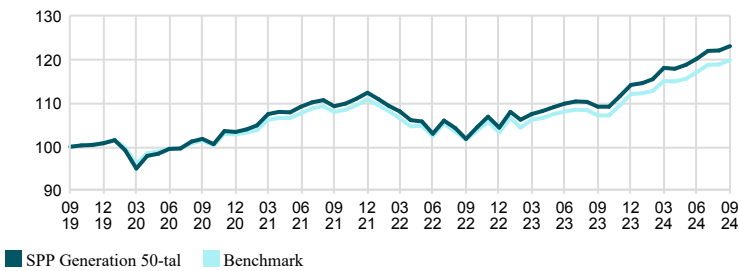
SPP Generation 50-tal is an actively managed multi asset fund which invests in Swedish as well as global equity and interest-bearing securities. The fund is a generation fund and is aimed at those of you who plan to retire during the period 2015-2024. The fund gradually reduces the risk over time and will until 2030 re-allocate from exposure against the stock market to the fixed income market. From the year 2030 onwards the fixed income allocation in the fund will normally be 80 per cent. The equity part of the fund is managed close to the benchmark and the fixed income part is actively managed. Through analysis and selection, the manager takes active investment decisions and allocates the fund's exposure between different asset classes and regions. The fund follows our standard for sustainable investments, which means, among other things, that we refrain from investing in companies that are in breach of international standards and conventions. These include human rights, labour law and international law, corruption and financial crime, serious climate and environmental damage, and controversial weapons (land mines, cluster bombs and nuclear weapons). We also exclude companies where more than 5 per cent of net sales come from the production and/or distribution of fossil fuels, tobacco, weapons, alcohol, gambling, pornography, cannabis, or companies with large fossil reserves.

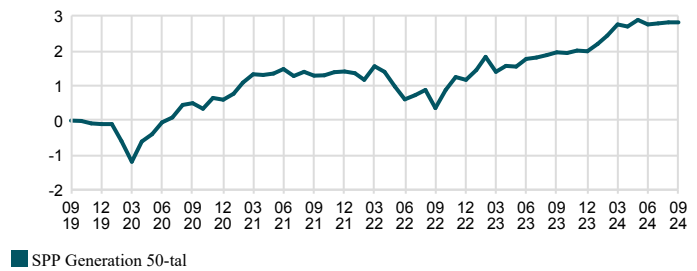

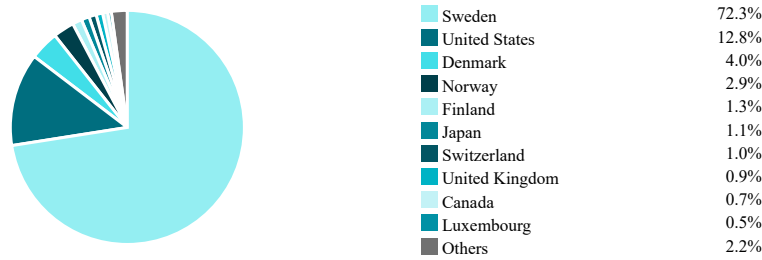
Excess Performance

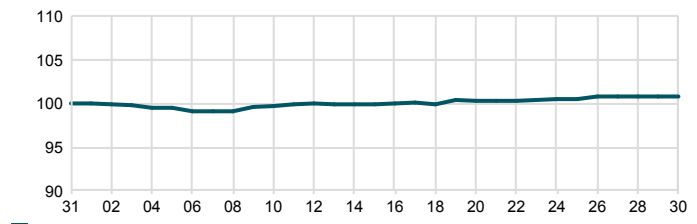

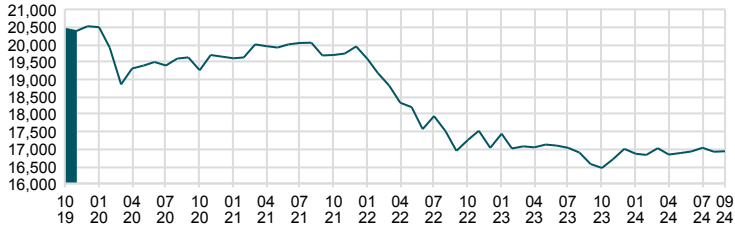

Total Assets

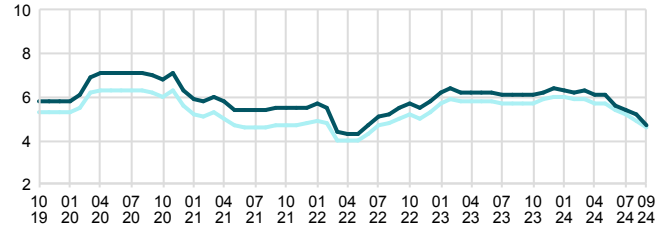

Rolling Window: 2 Years 1 Month shift

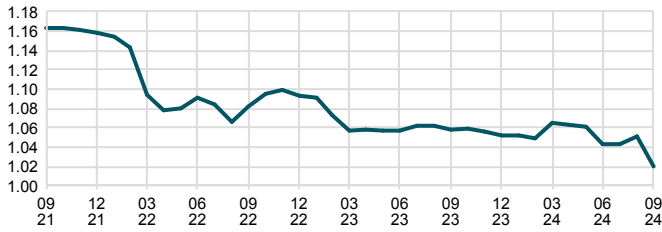

Rolling Window: 2 Years 1 Month shift

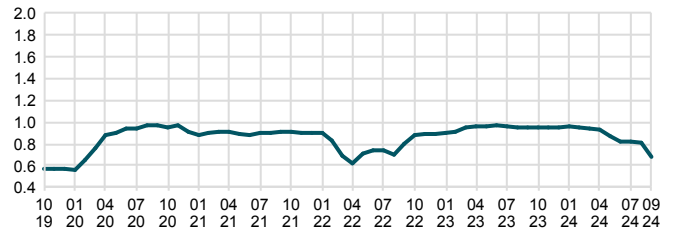

Time Period: 2019-10-31 to 2024-09-30

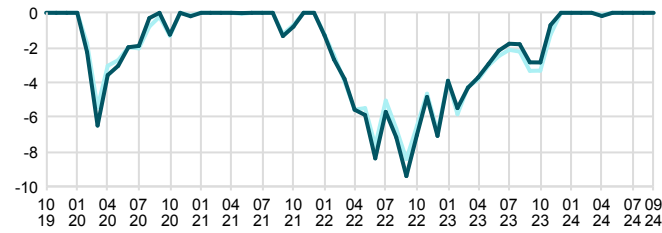
Rolling Window: 2 Years 1 Month shift

Drawdown

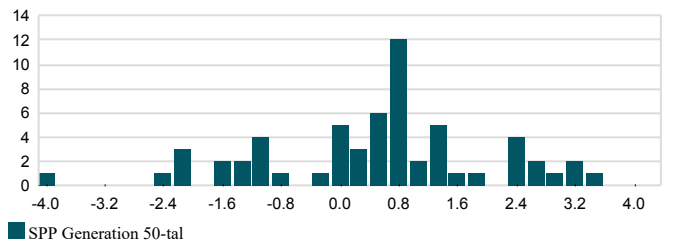
