-The Fund invests primarily in global listed infrastructure and infrastructure-related equity or equity related securities worldwide. The Fund aims to achieve a total investment return consistent with income and long term capital growth. It invests primarily in a diversified portfolio of listed Infrastructure and Infrastructure-related equity securities and equity related securities of issuers listed, traded or dealt in on regulated markets worldwide.
