1. The Fund invests primarily in an actively managed globally diversified portfolio of fixed income instruments.
2. The Fund's investment may be concentrated in specific countries or regions and the value of the Fund may be more volatile.

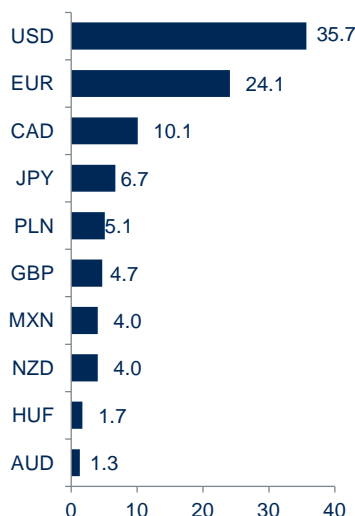

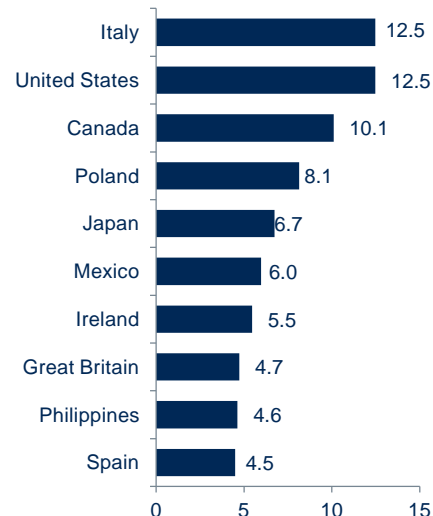
