#### Important Information

- The Fund invests in a portfolio of equity or equity related instruments of European companies with an emphasis on larger companies.



The net asset value of the MD-1 hedged may fluctuate and may significantly differ from other share class due to fluctuation of the interest rate differential between the currency in which the MD-1 hedged is denominated and the base currency of the Fund and may result in a greater erosion of capital than other non-hedged share class. (Note 2) The value of the Fund can be volatile and could go down substantially. Investors should not base their investment decision on this material alone.
